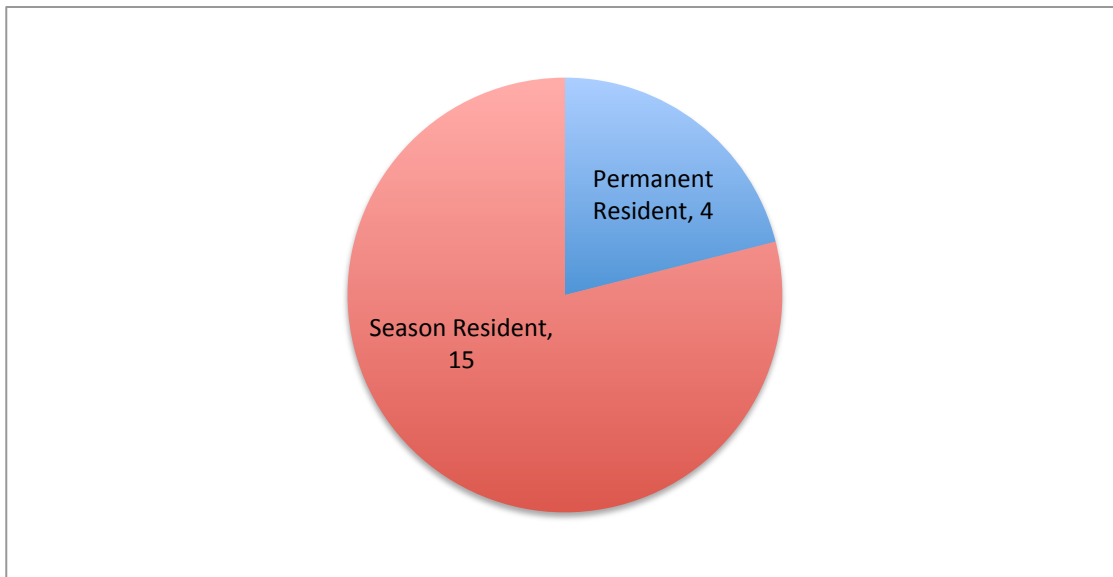

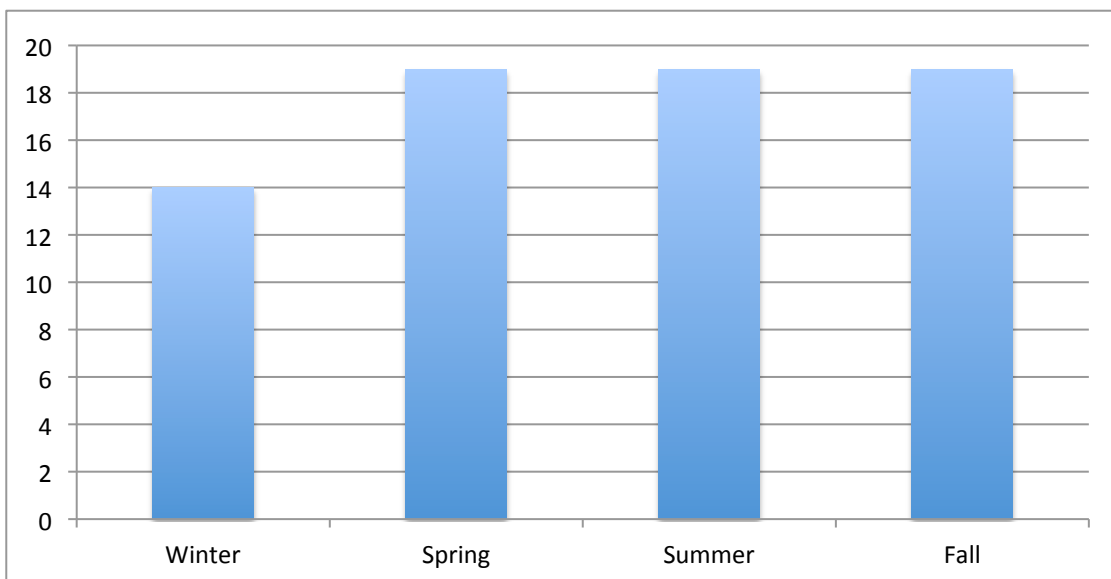

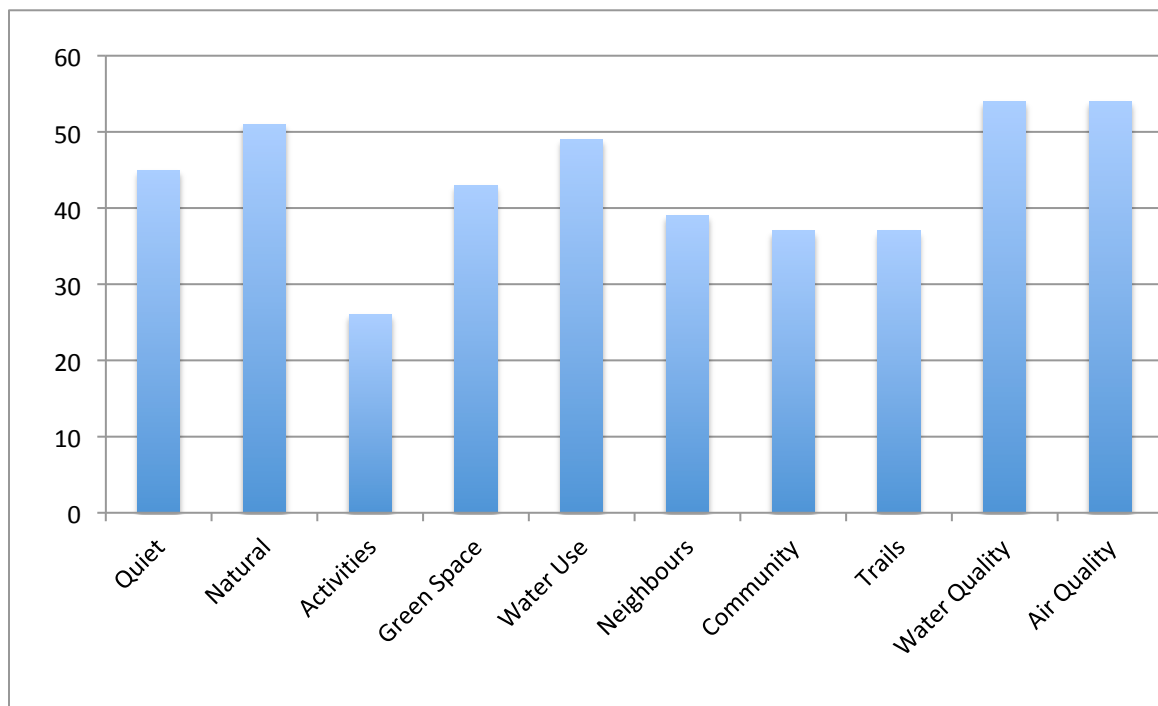
1. Percent permanent to seasonal resident



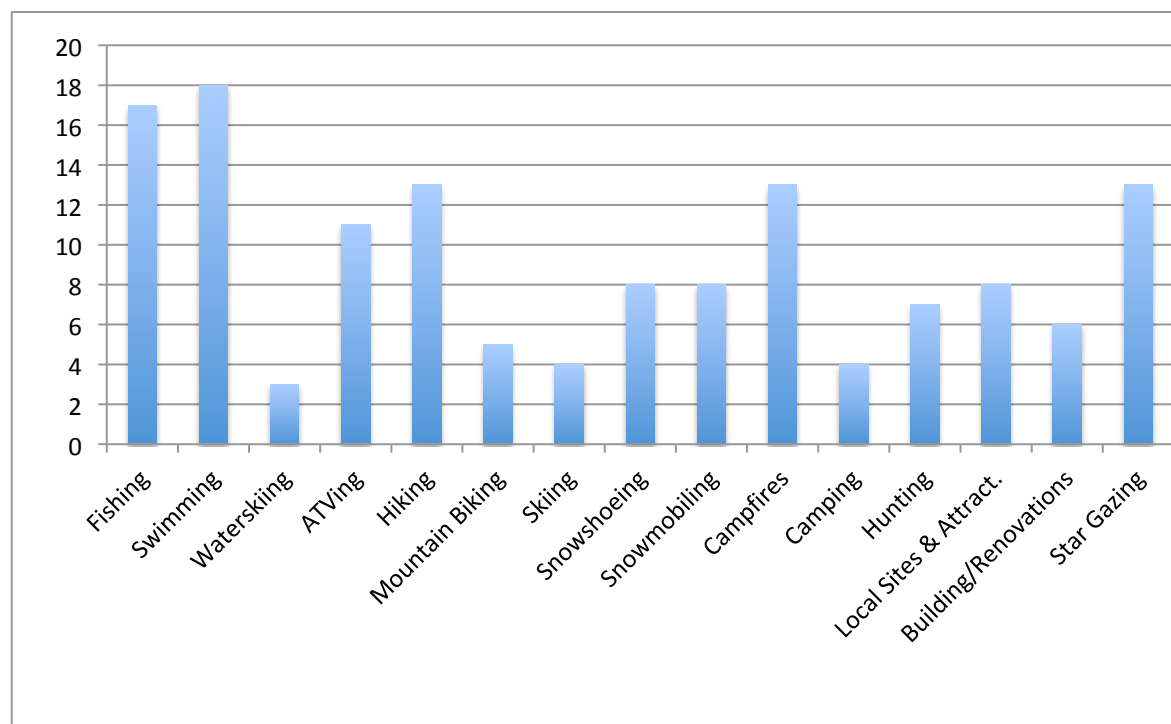
2. Amount of seasonal usage by survey respondents



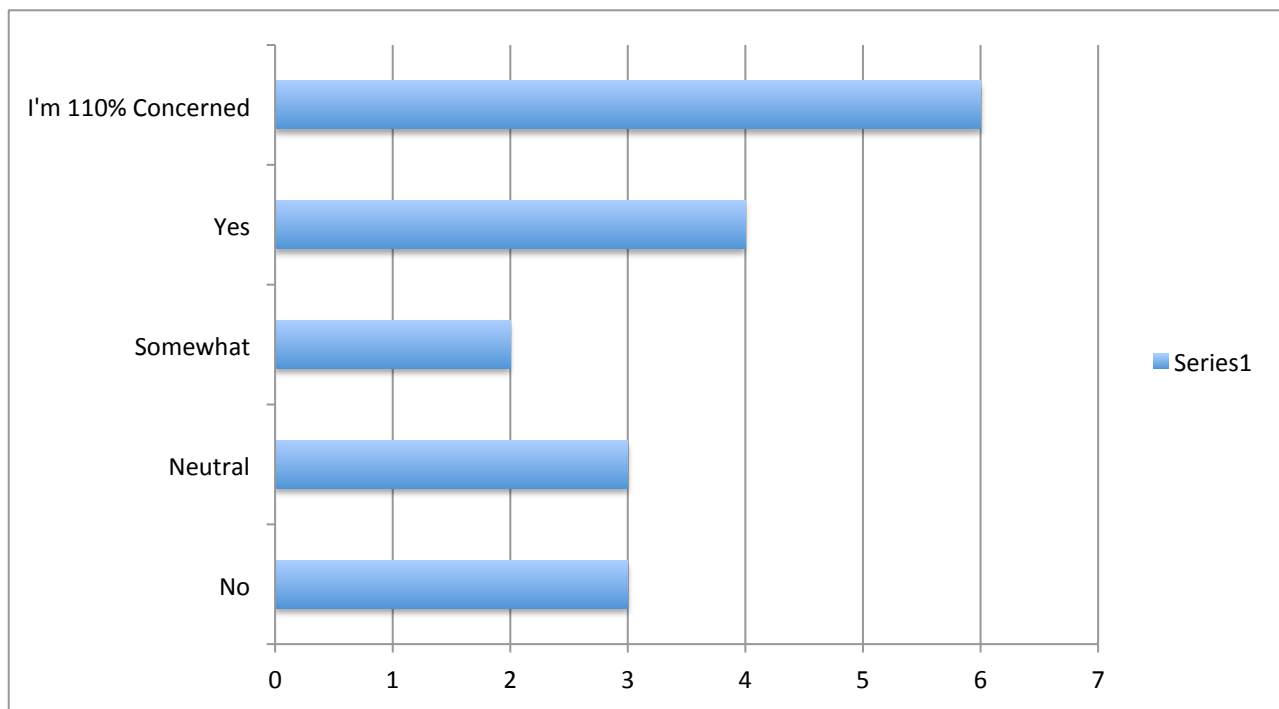
3. How respondents ranked the importance of these traits



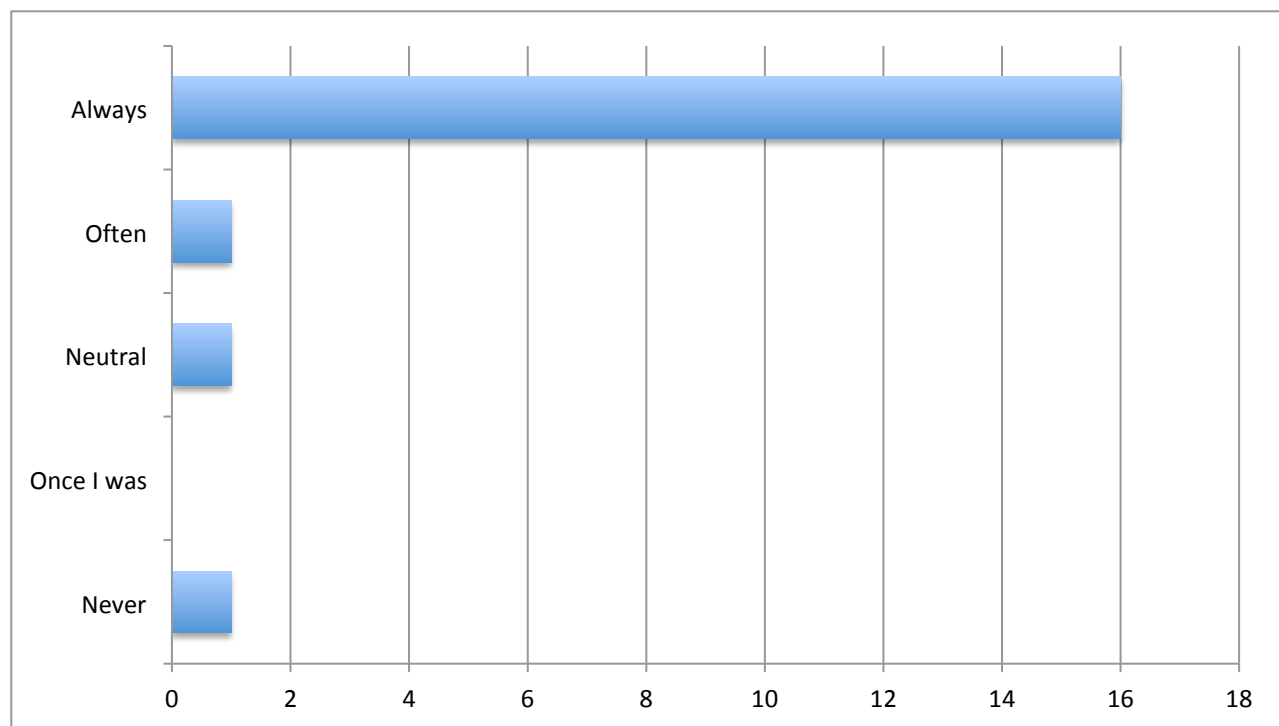

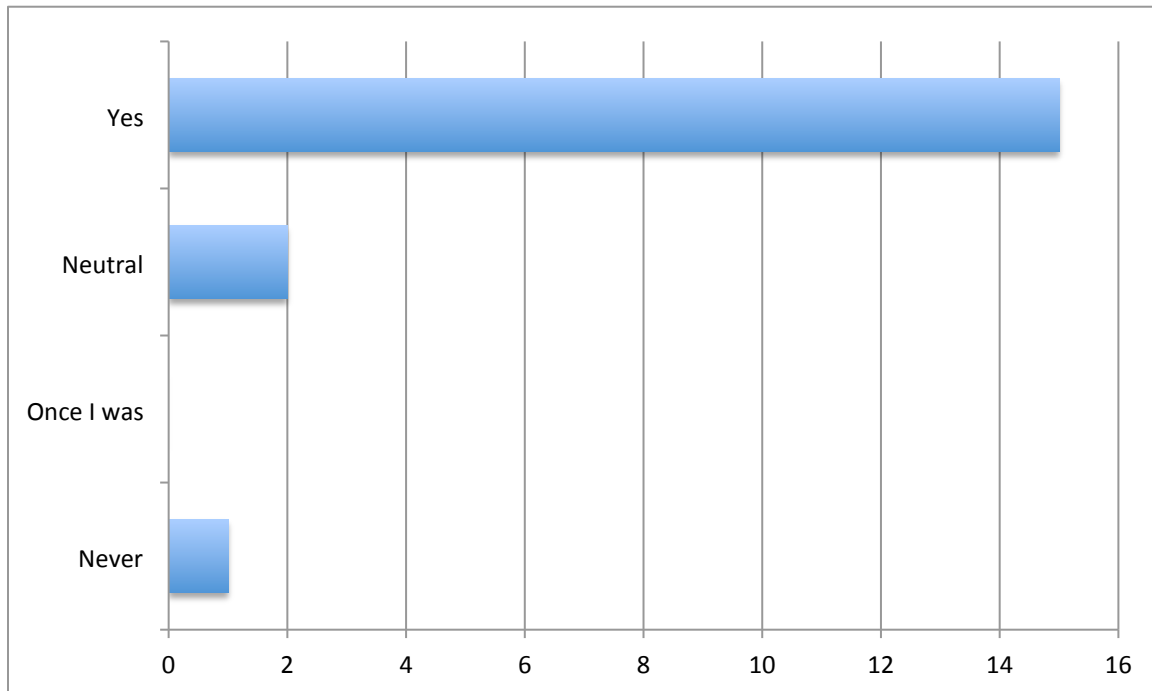

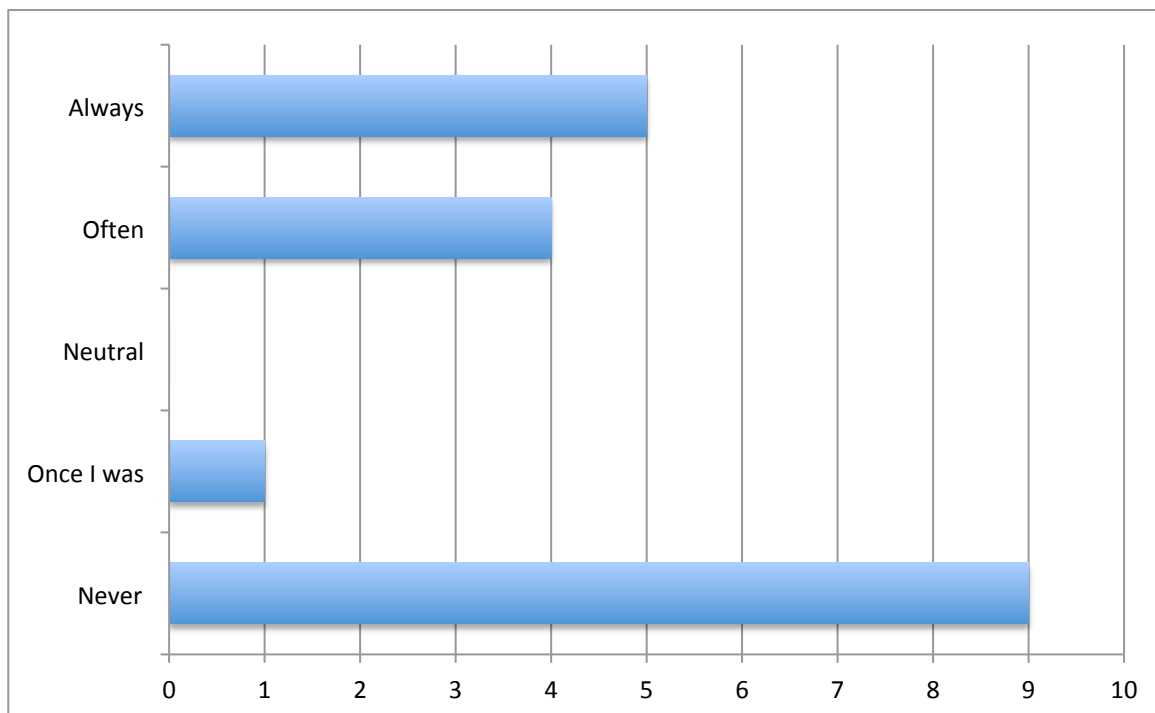

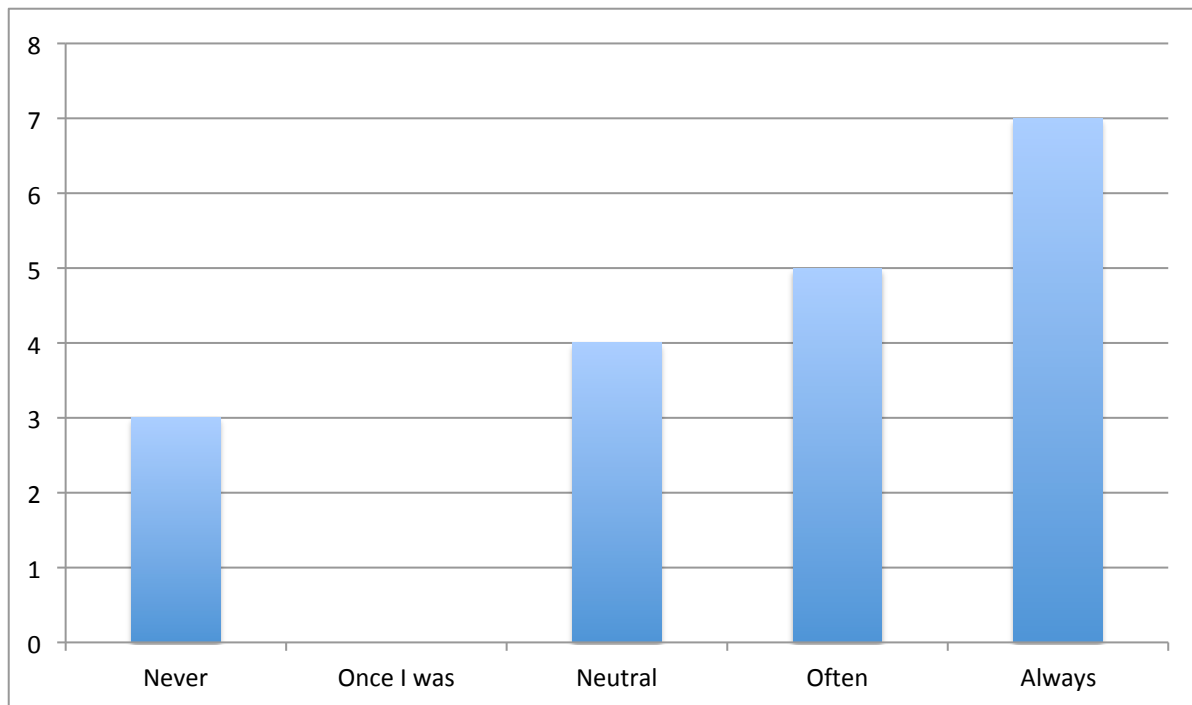

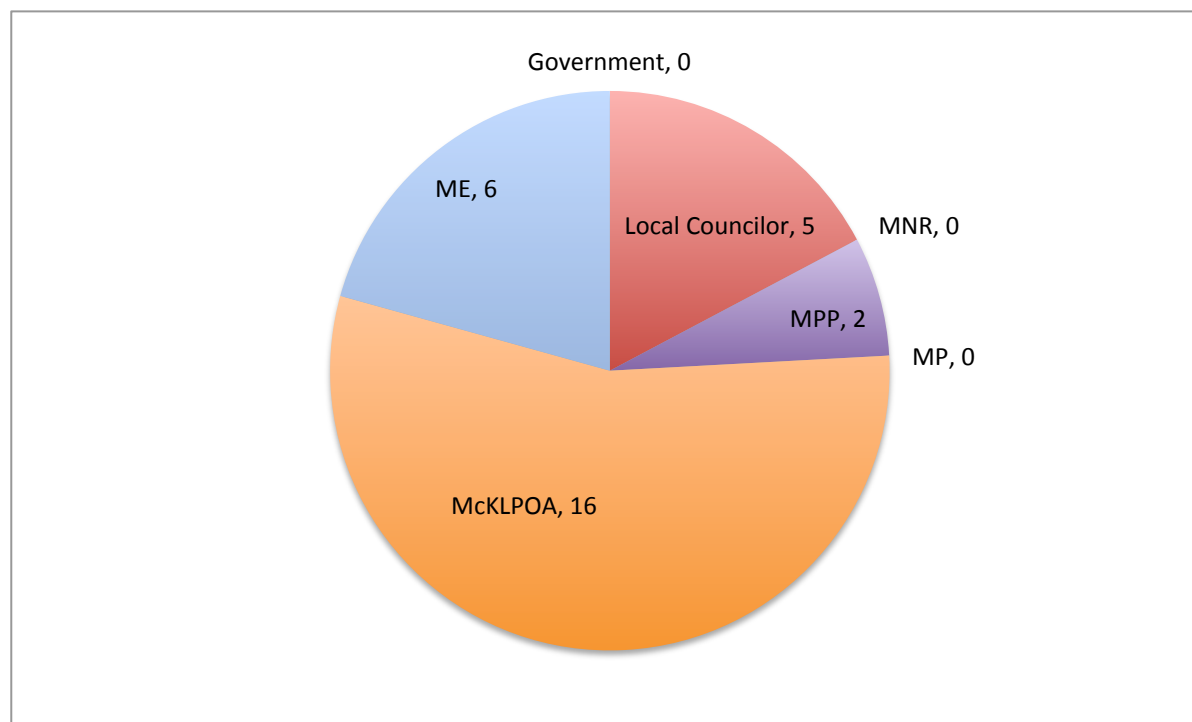

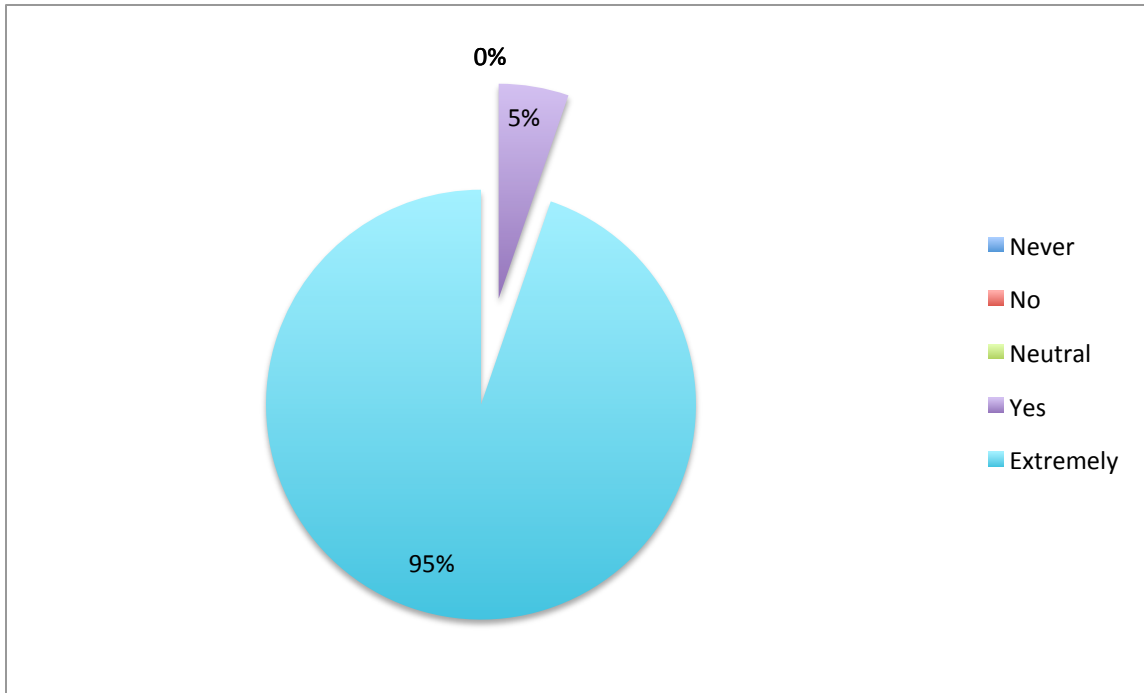

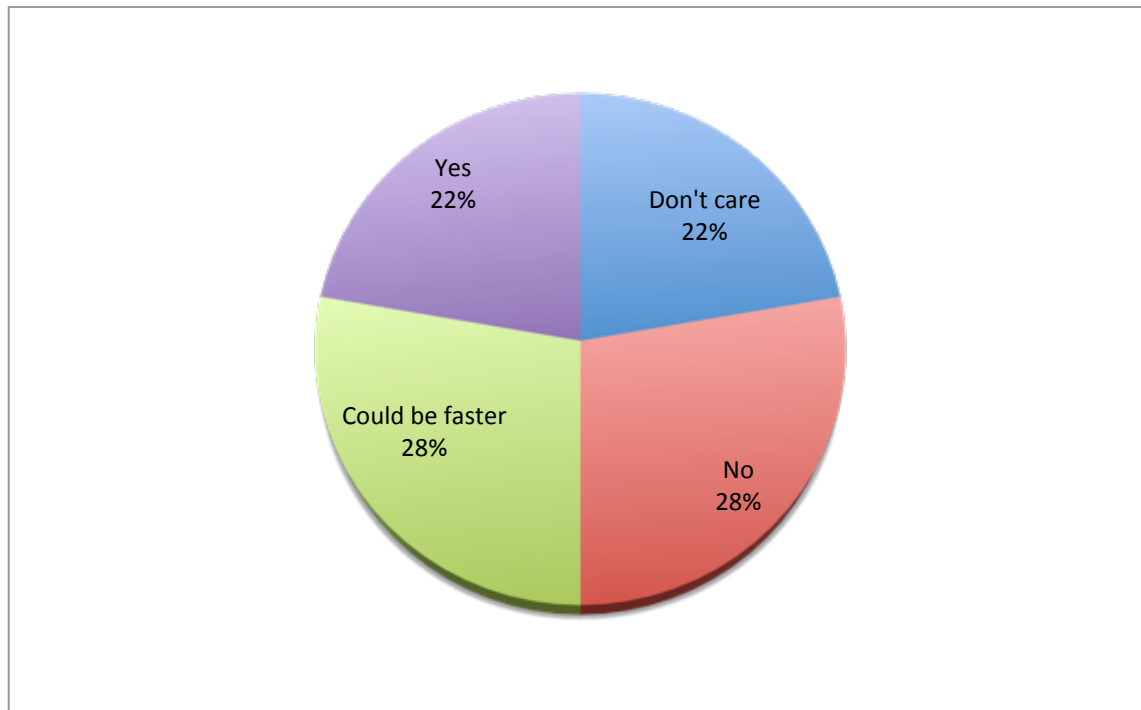

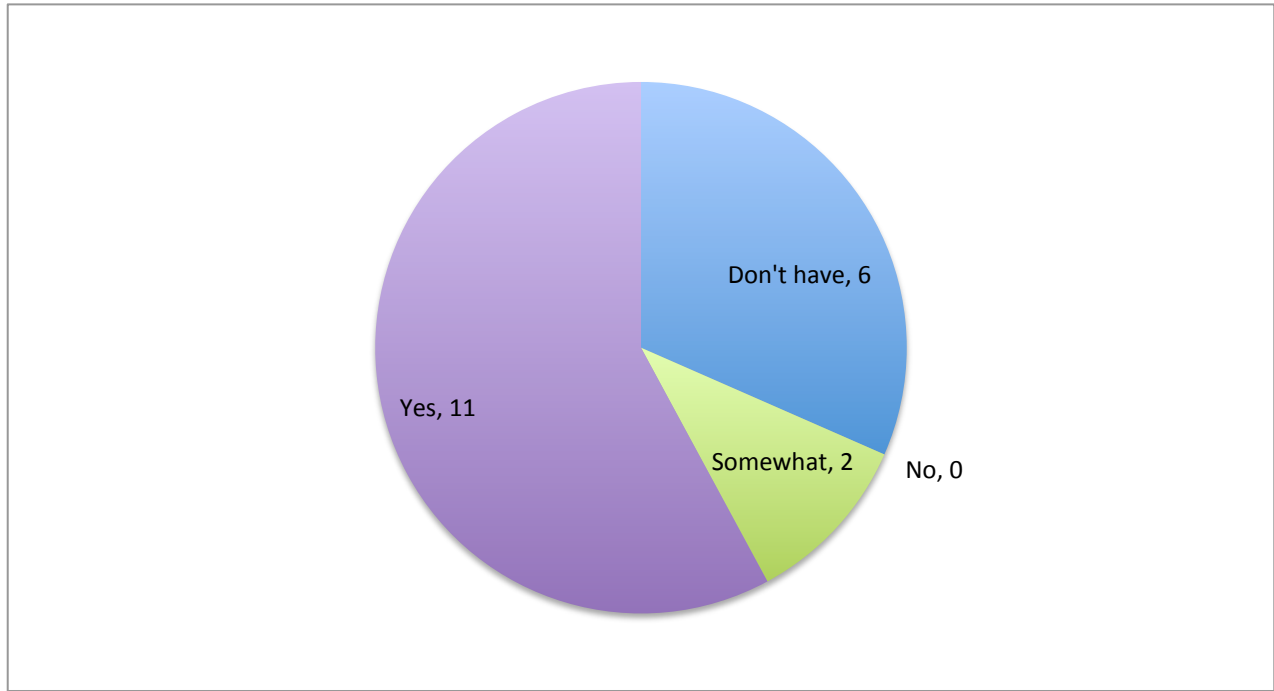

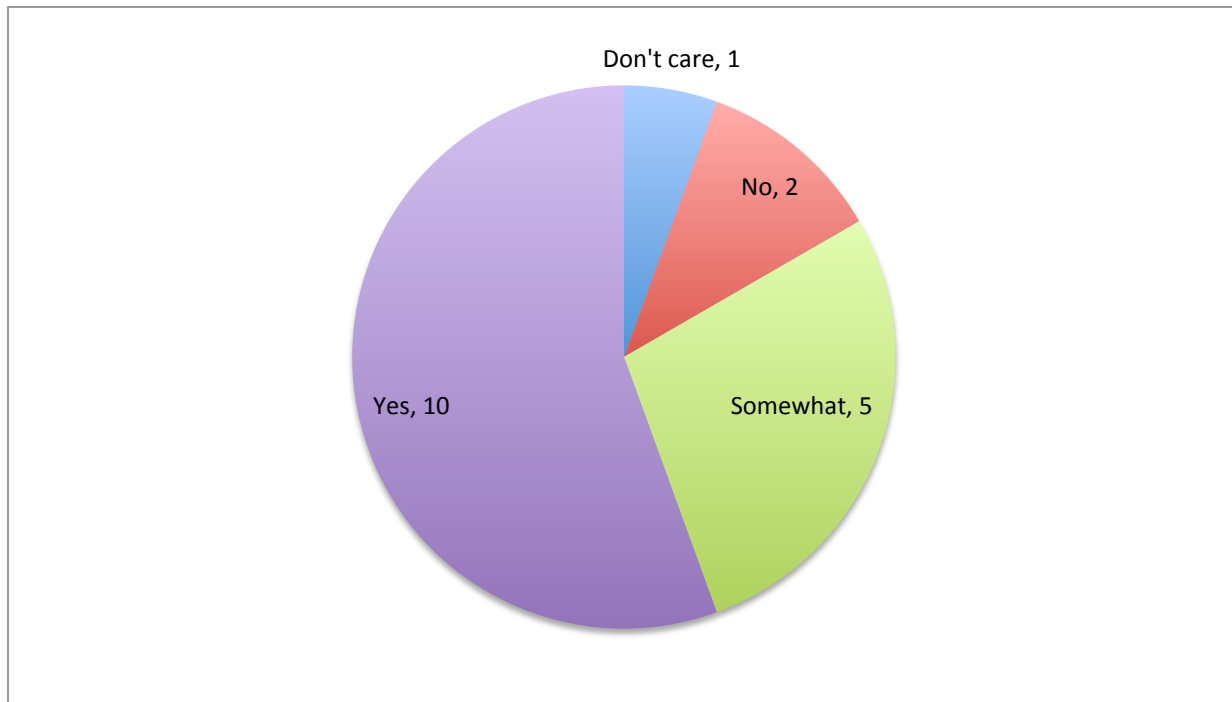

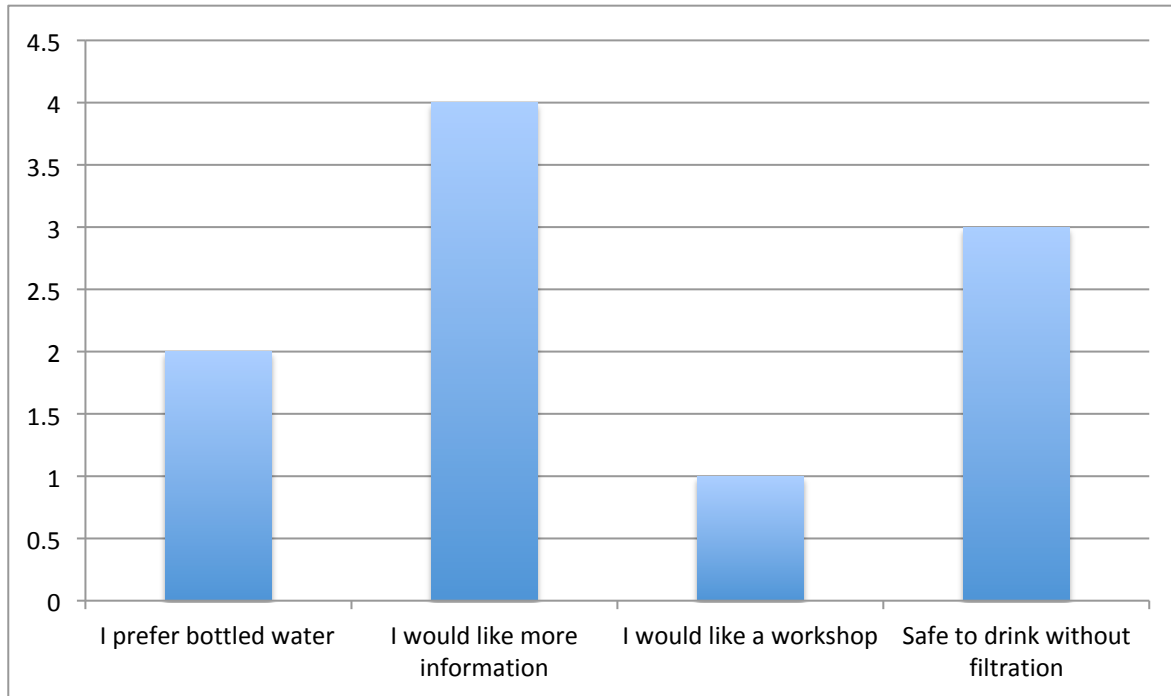

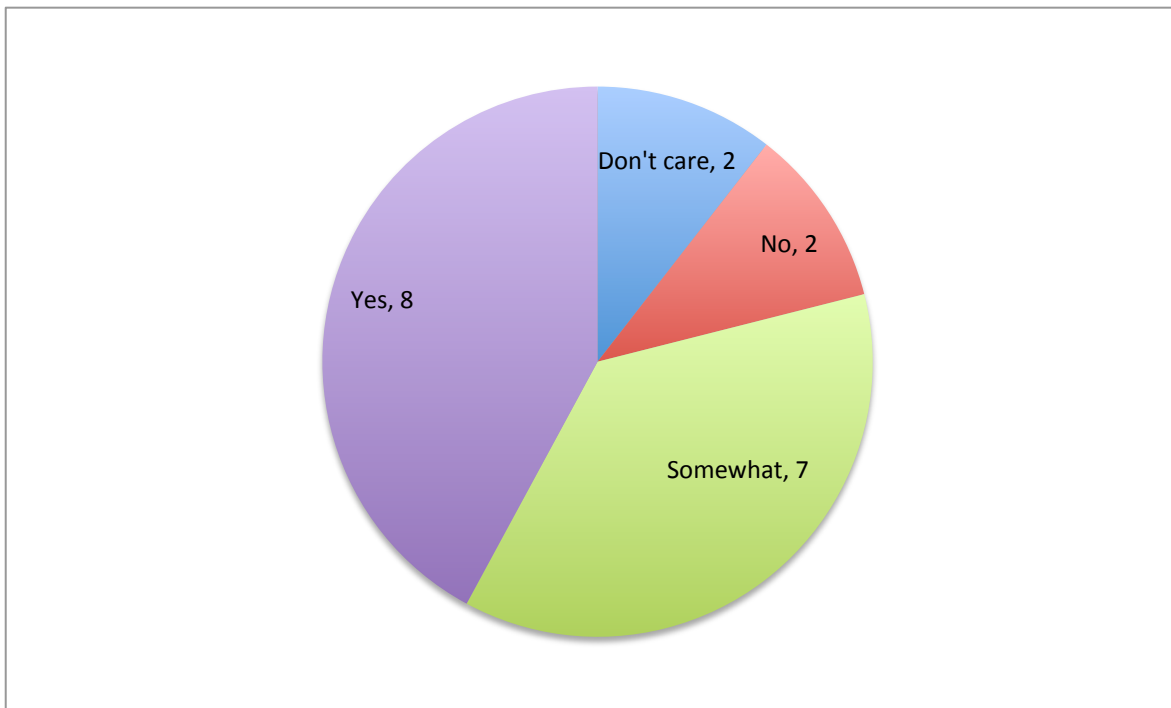
14. Percent respondents satisfied with Policing in area.



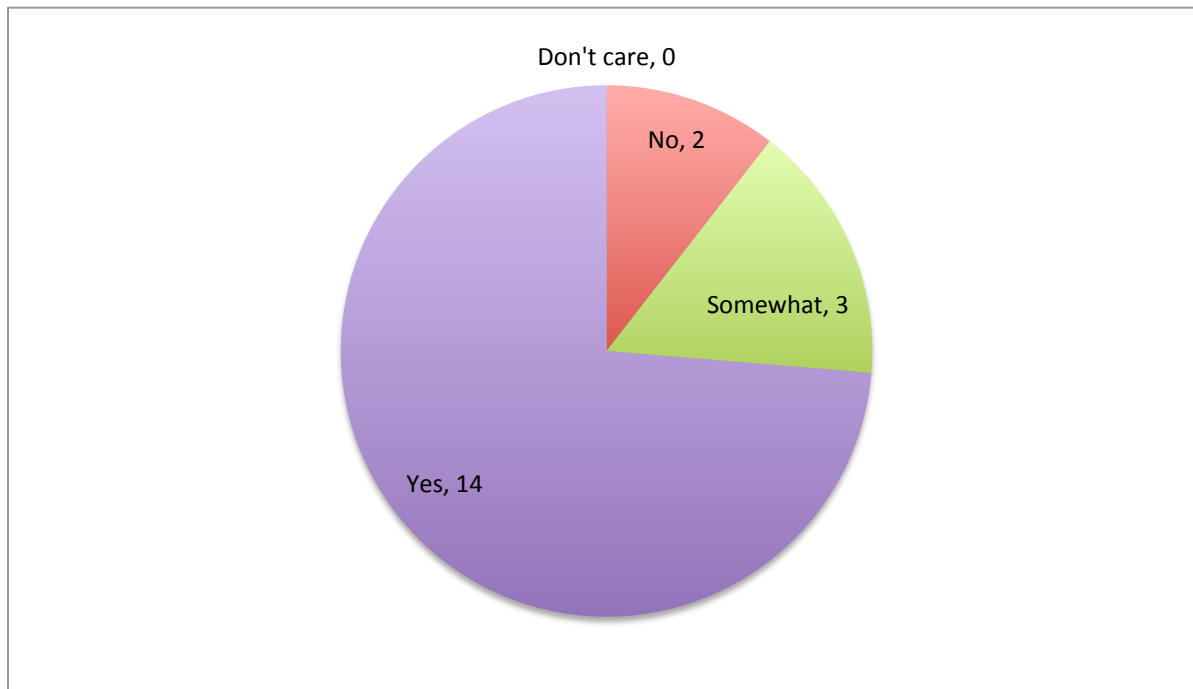

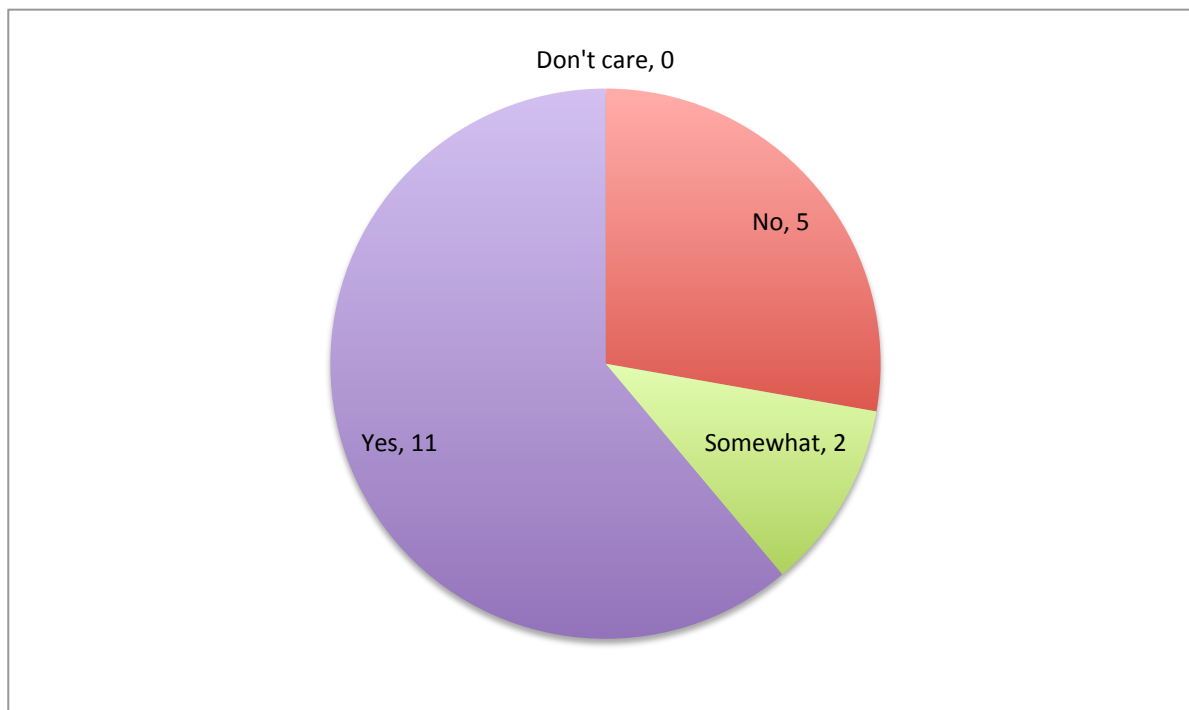

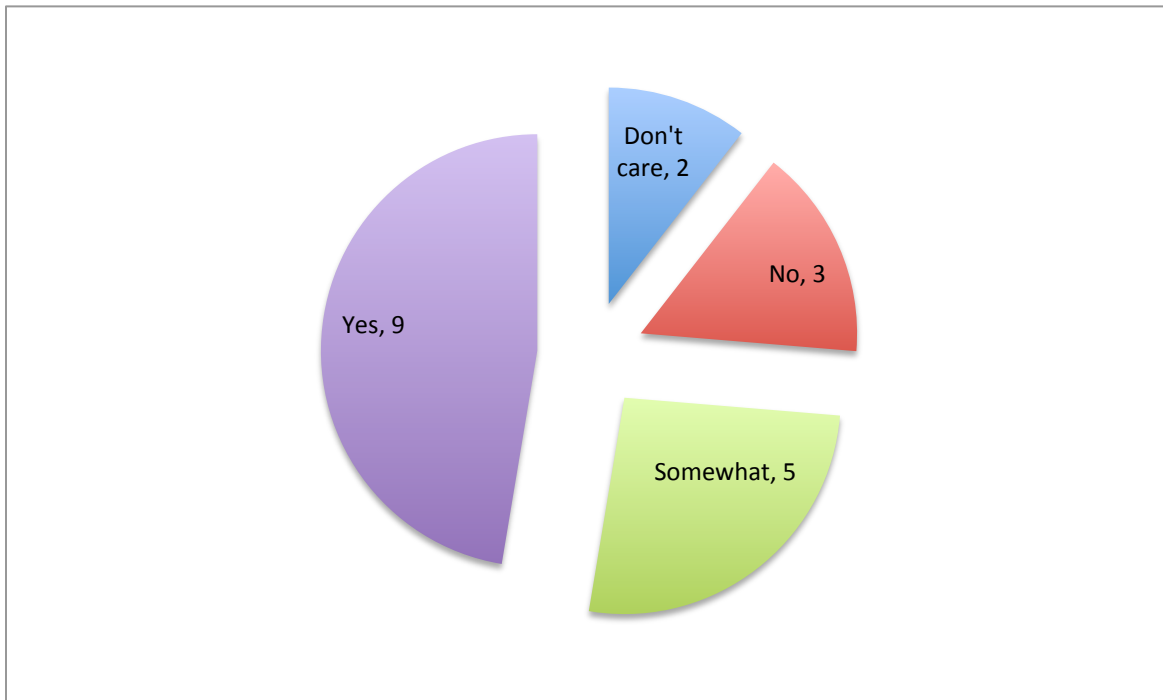

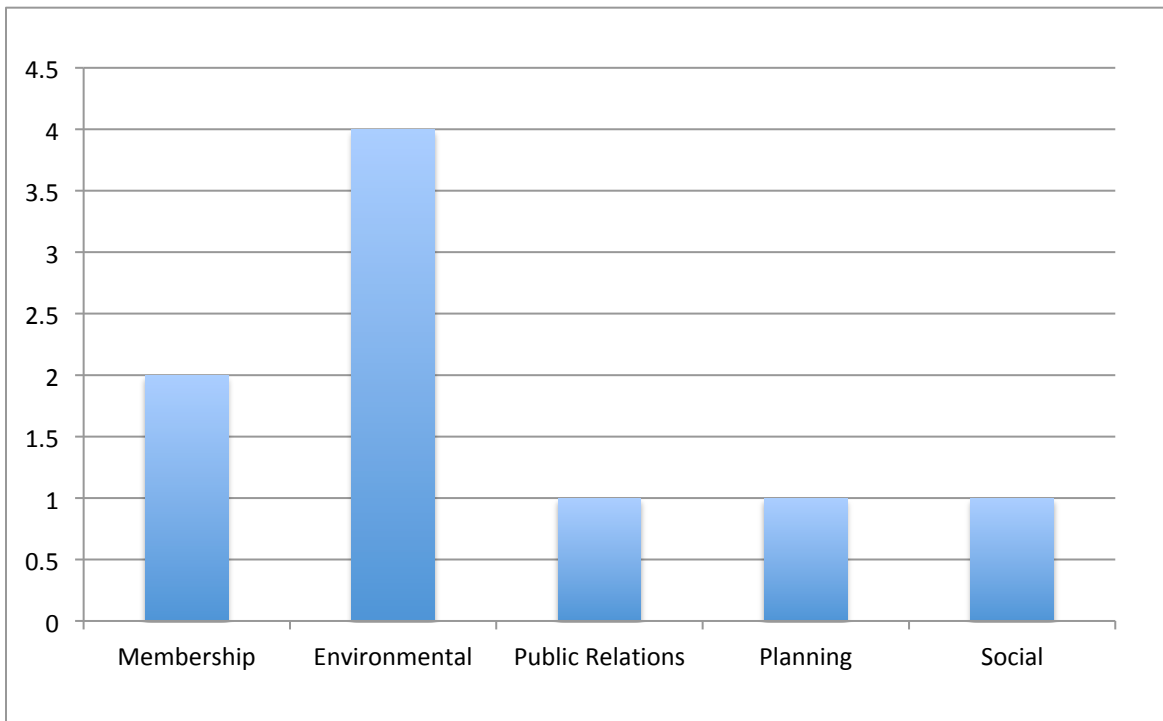
18. Percent respondents aware there is an environmental committee

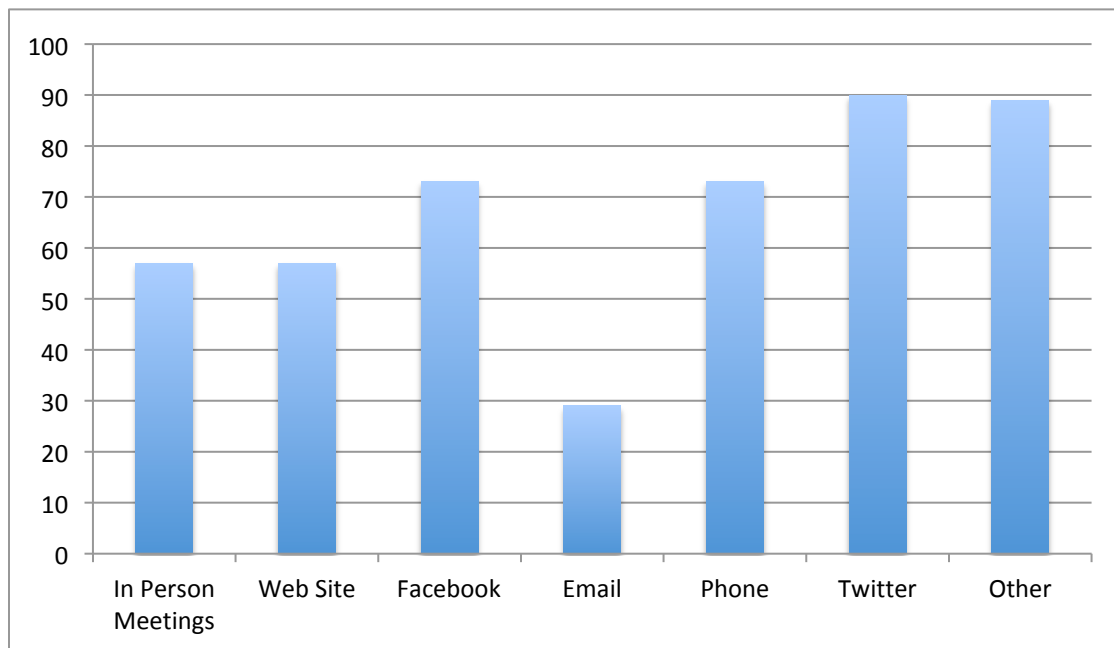


20. Number of respondents who would like to get involved in identified committees



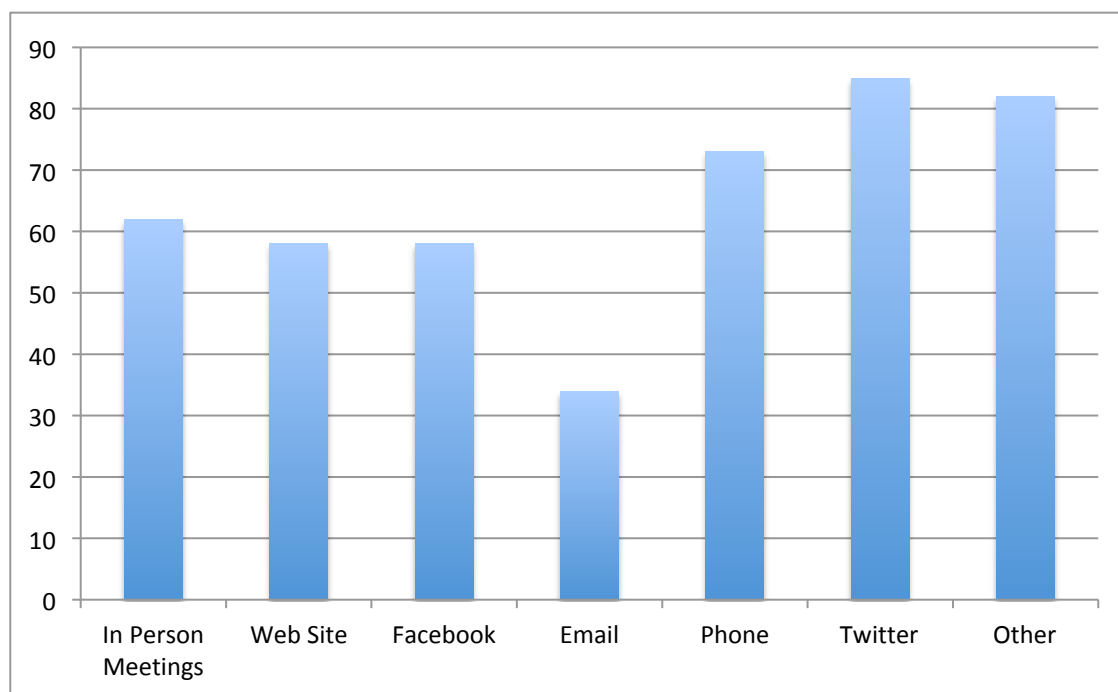
21. Weighted ranking of best ways to share CONFIDENTIAL Association Information

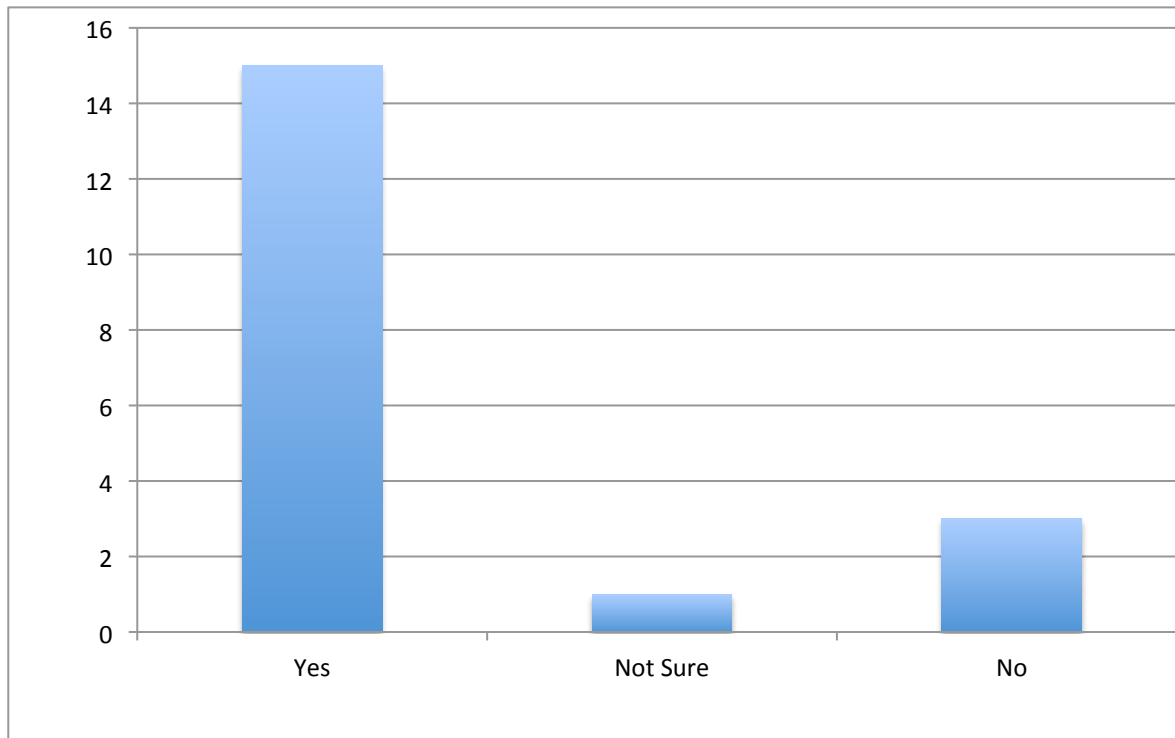


22. Weighted ranking of best way to share SOCIAL area information

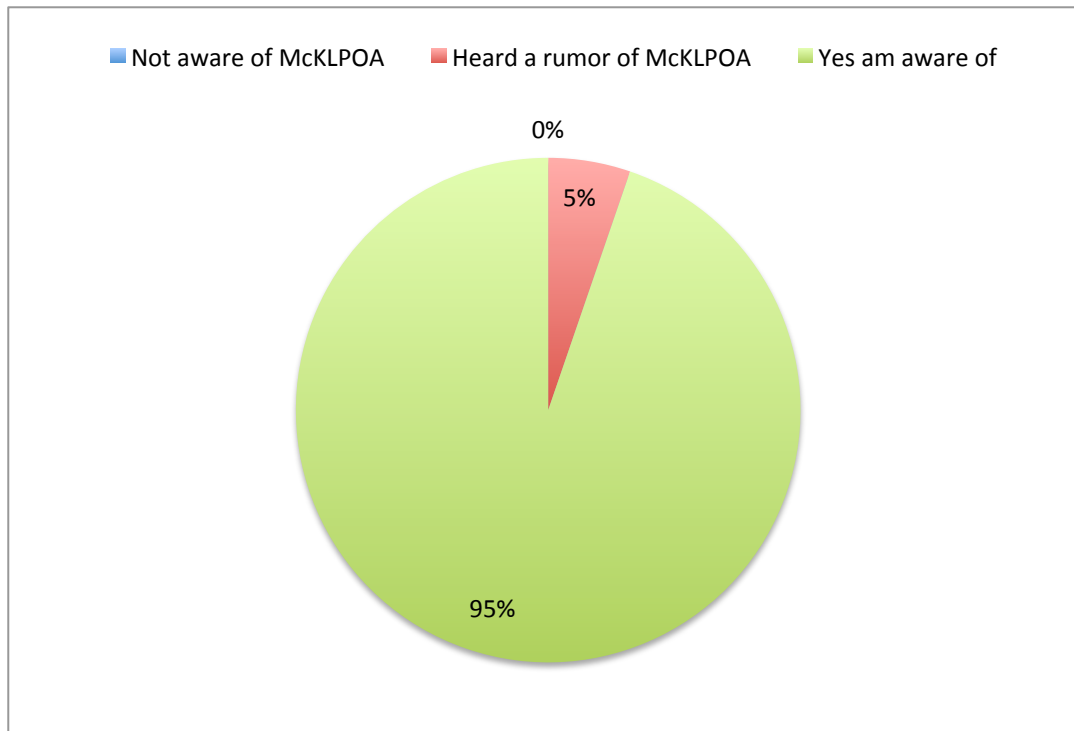

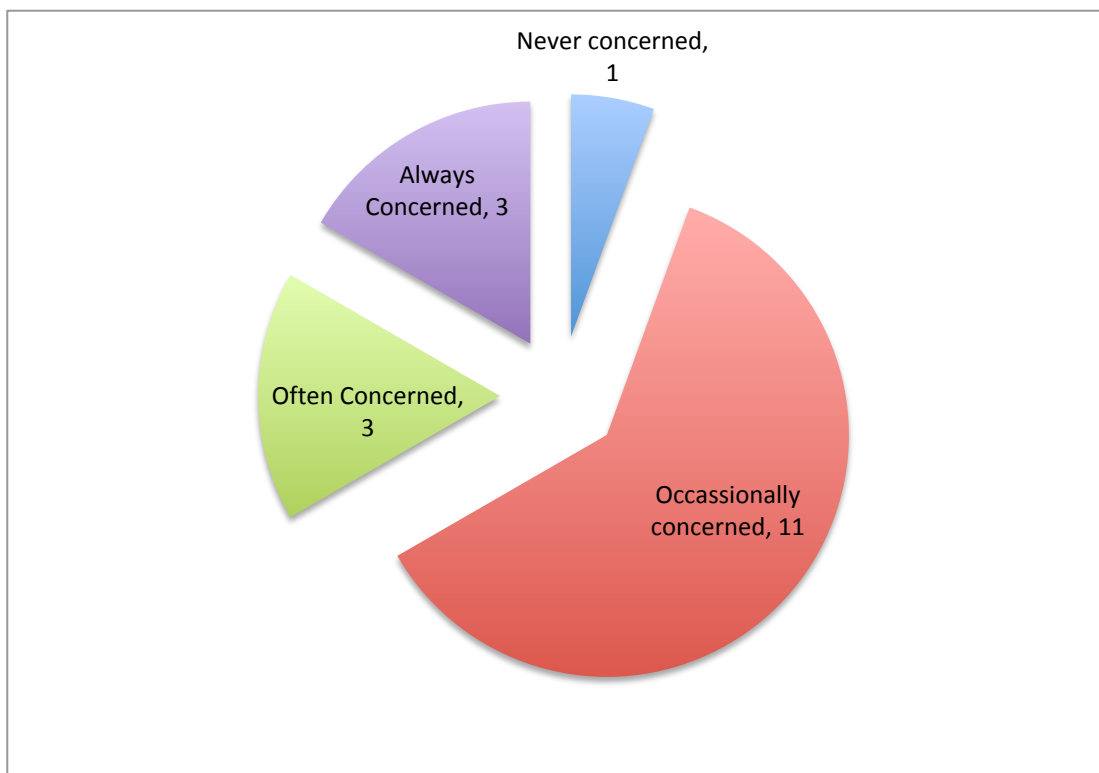

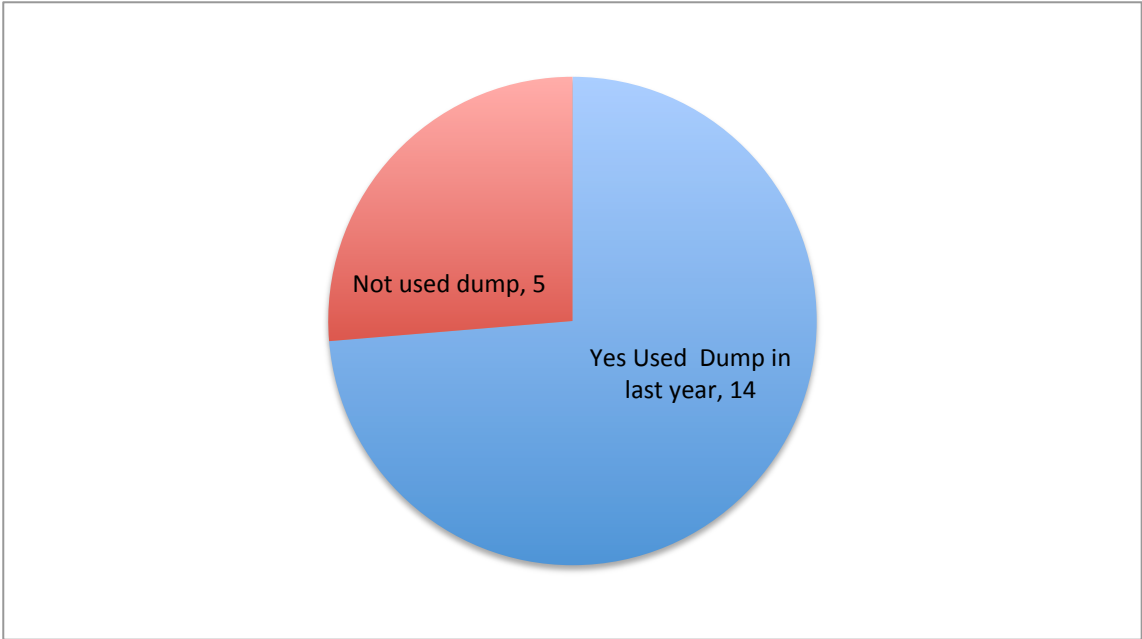

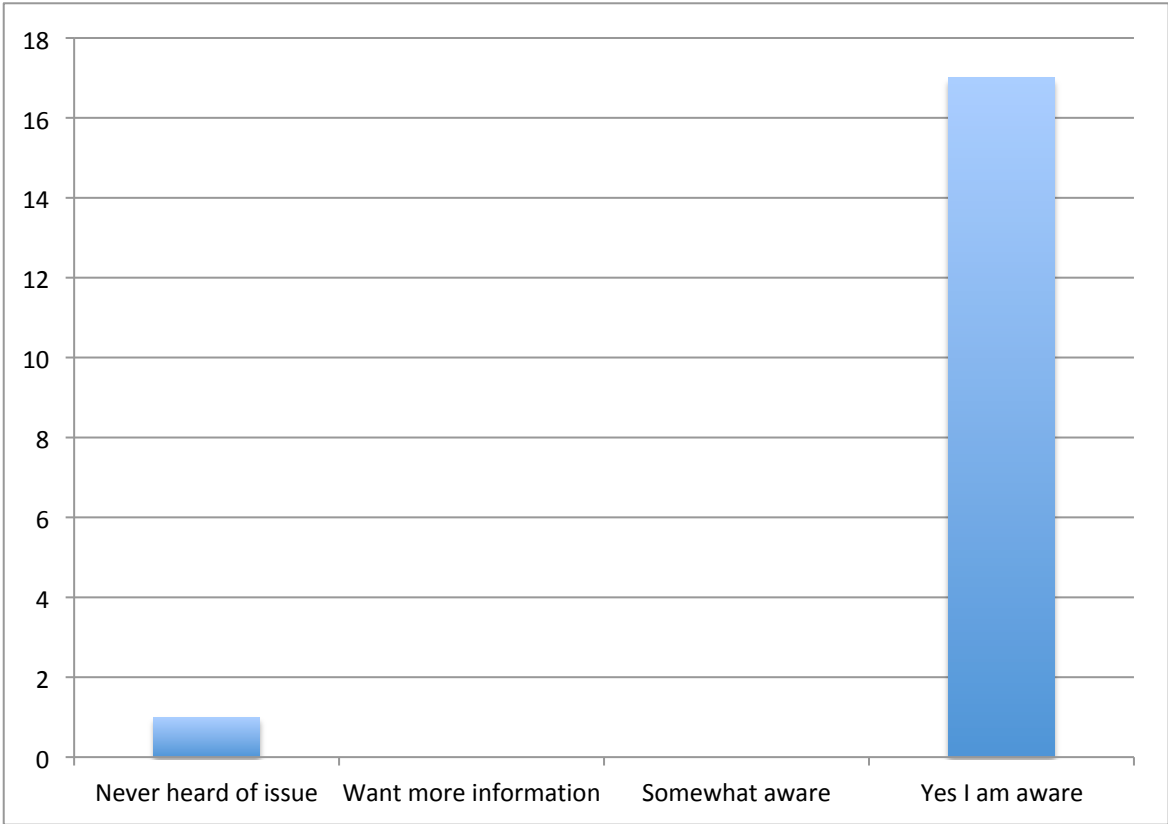

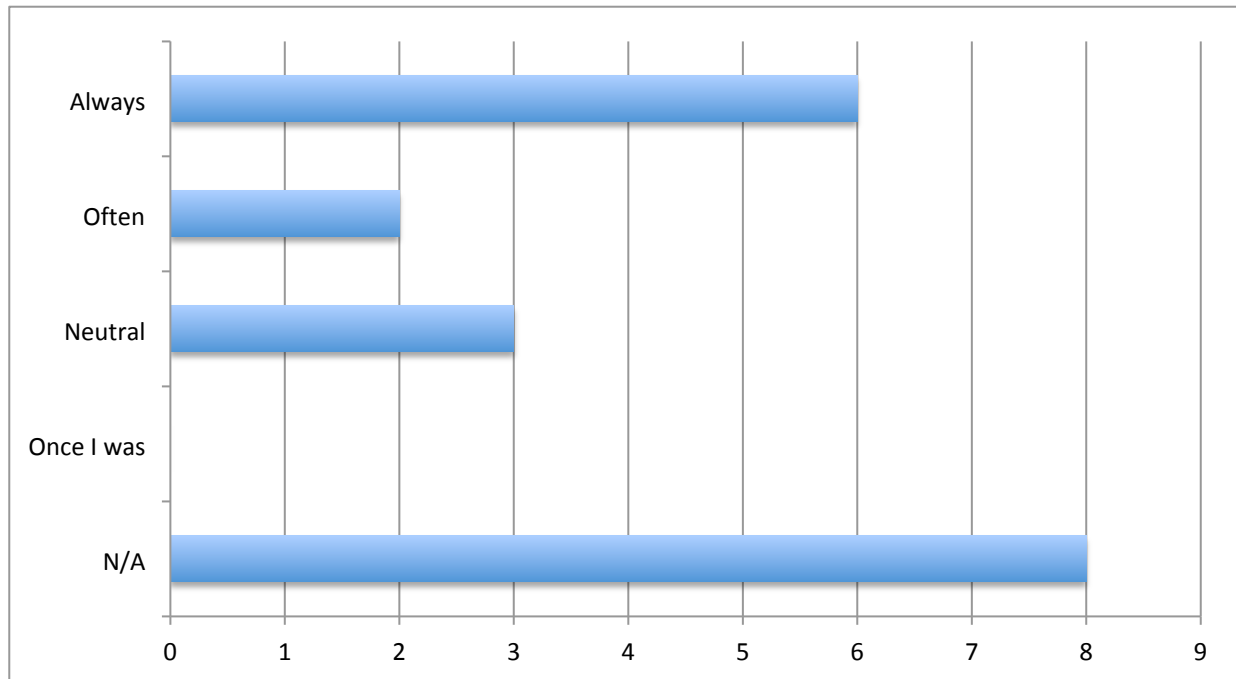

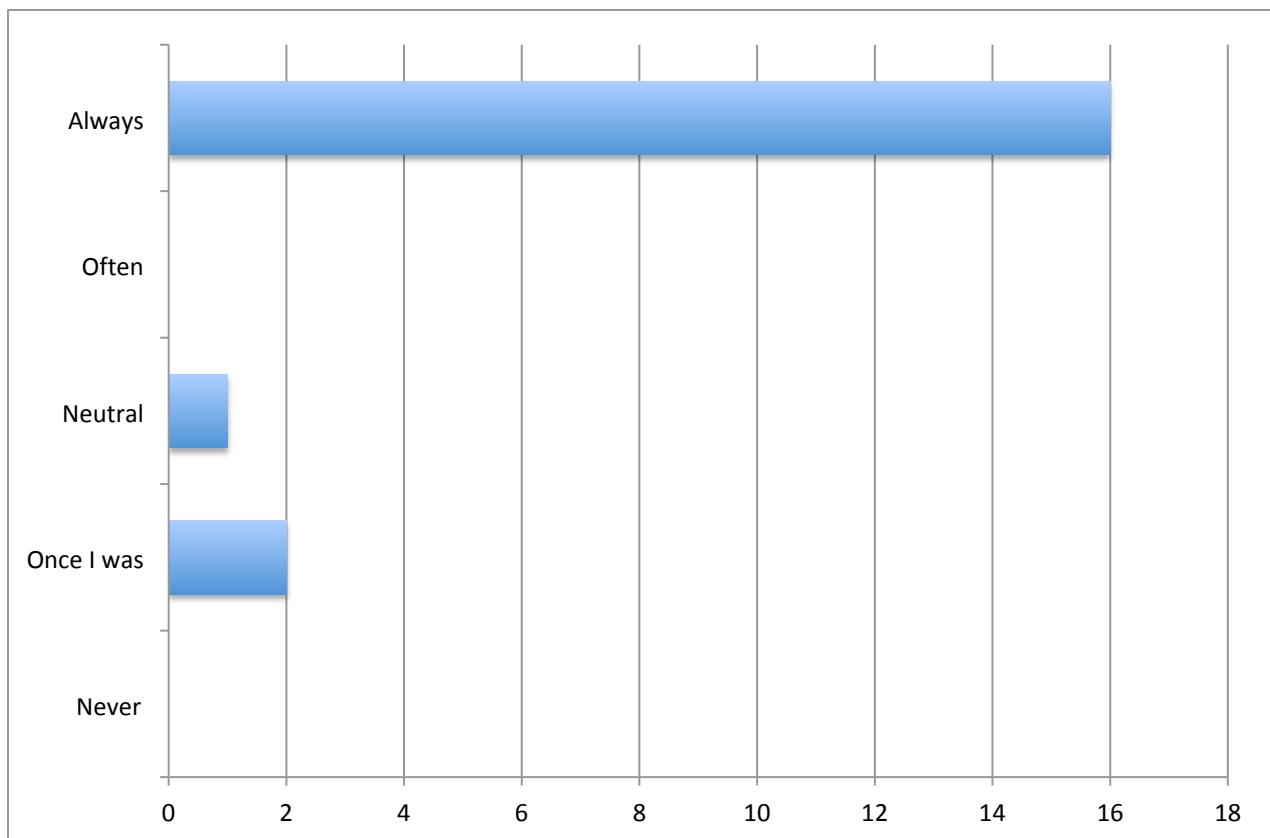

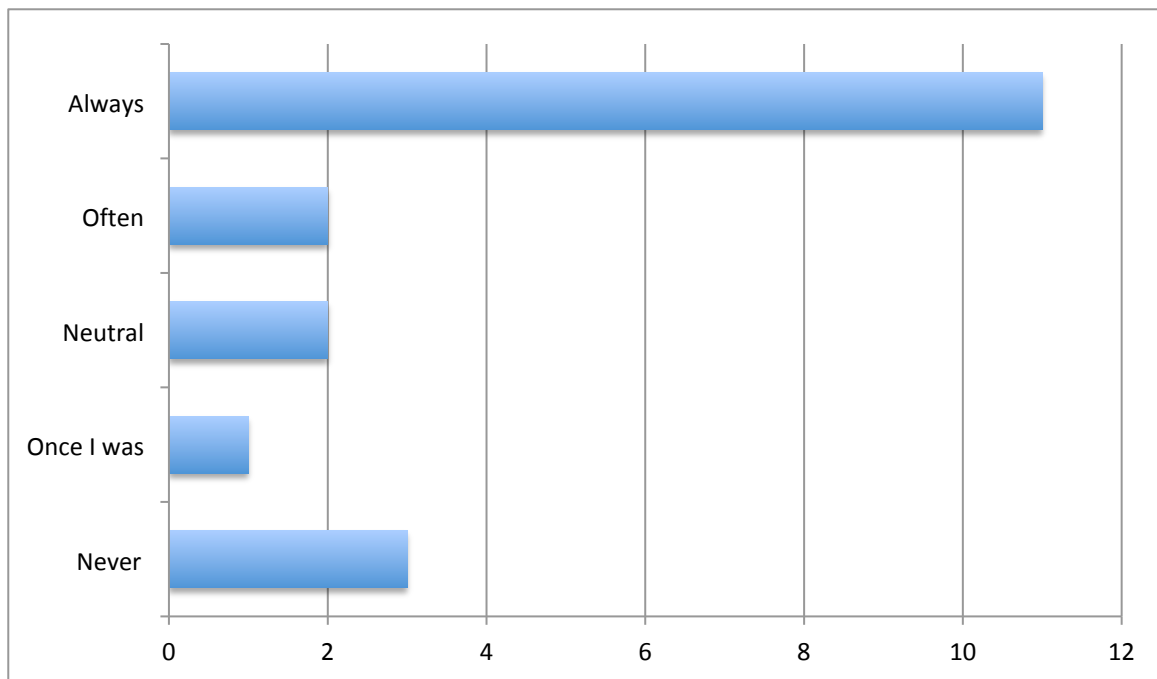

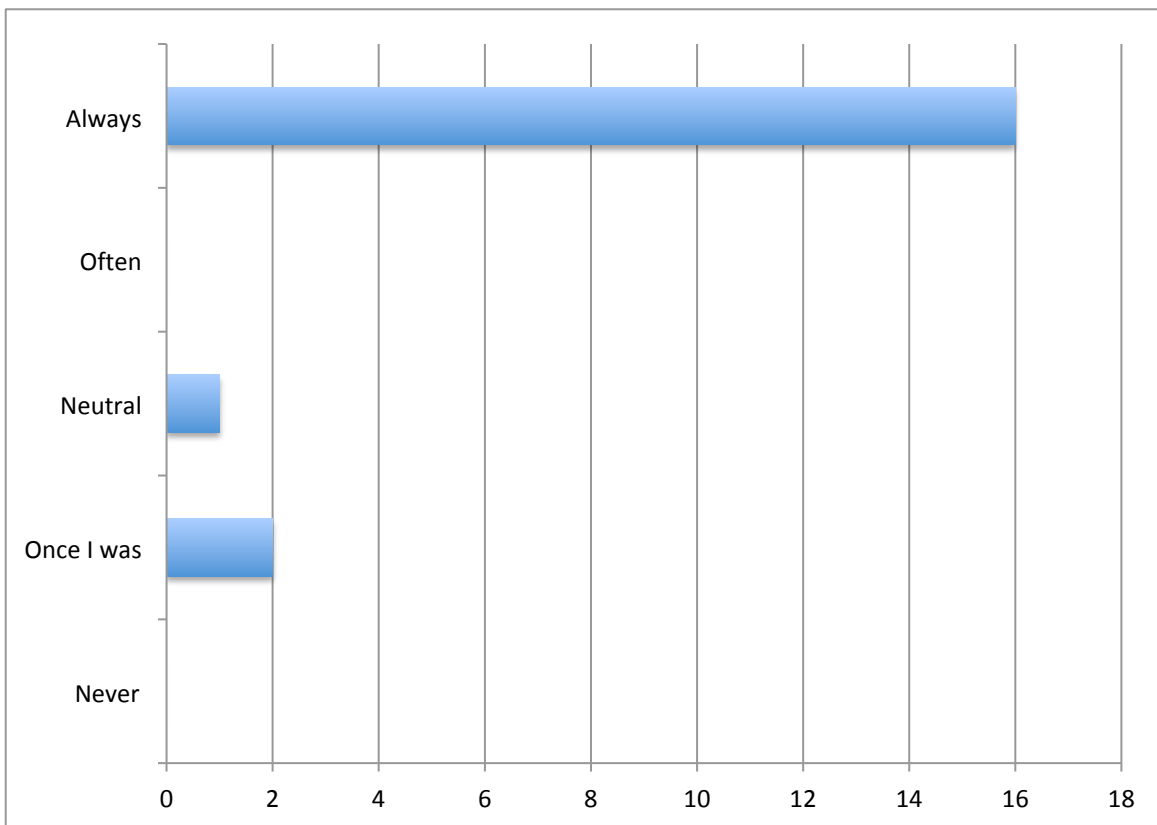

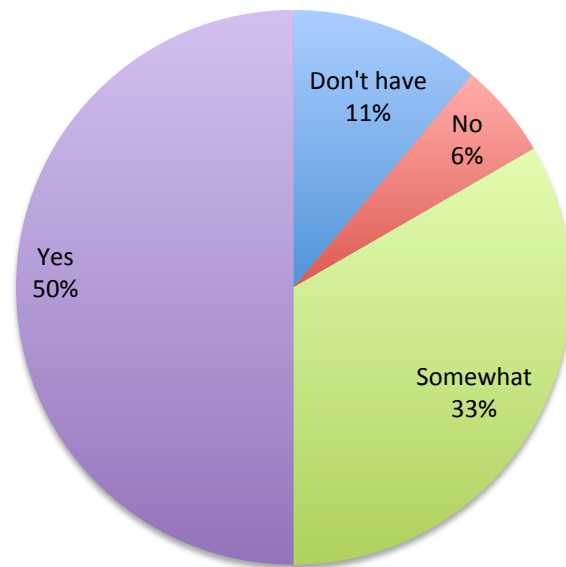

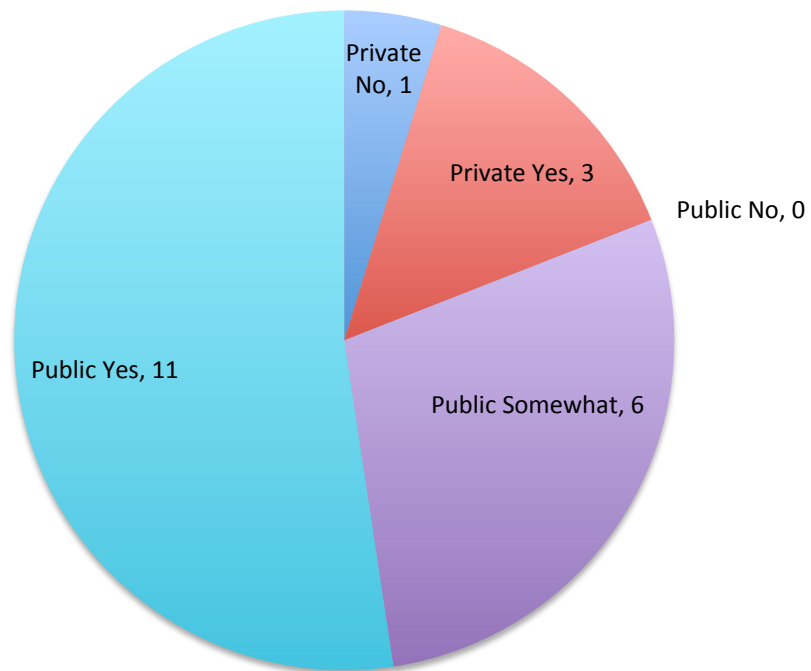

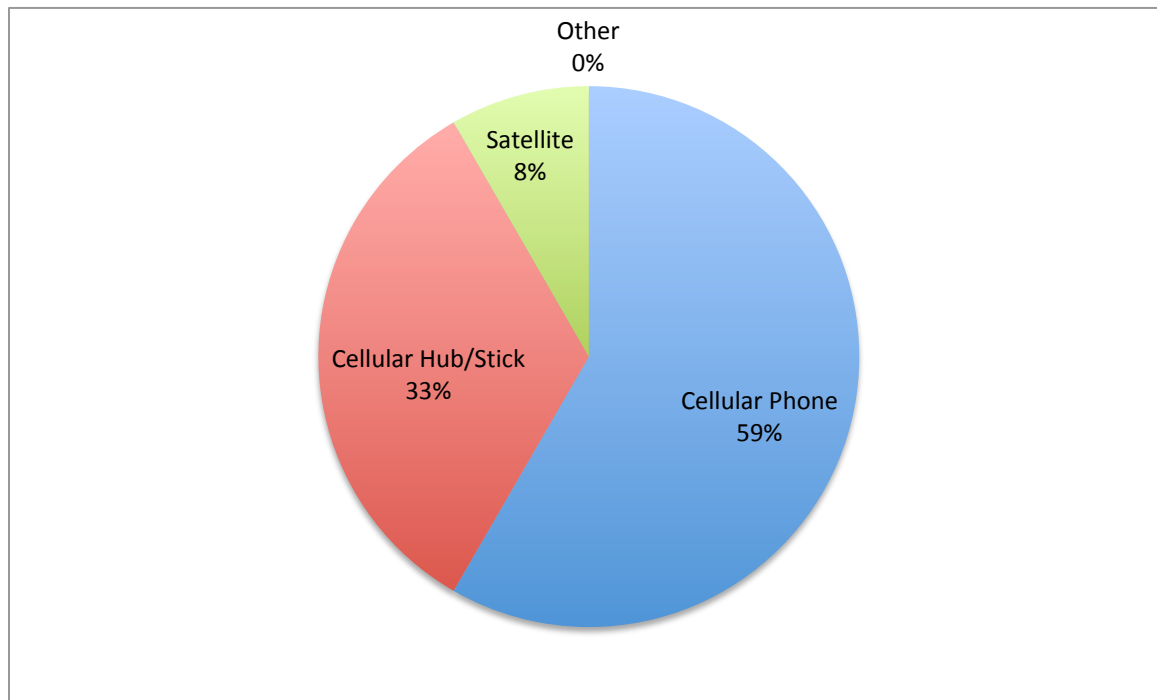

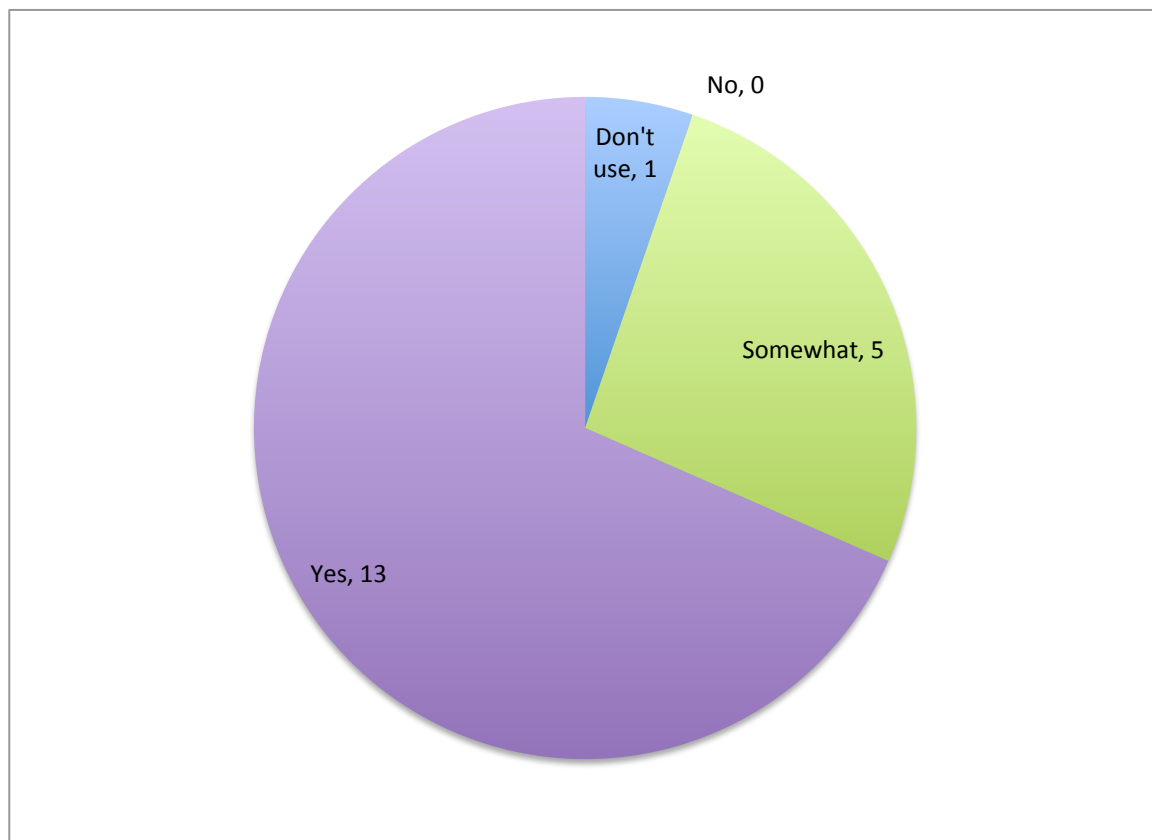

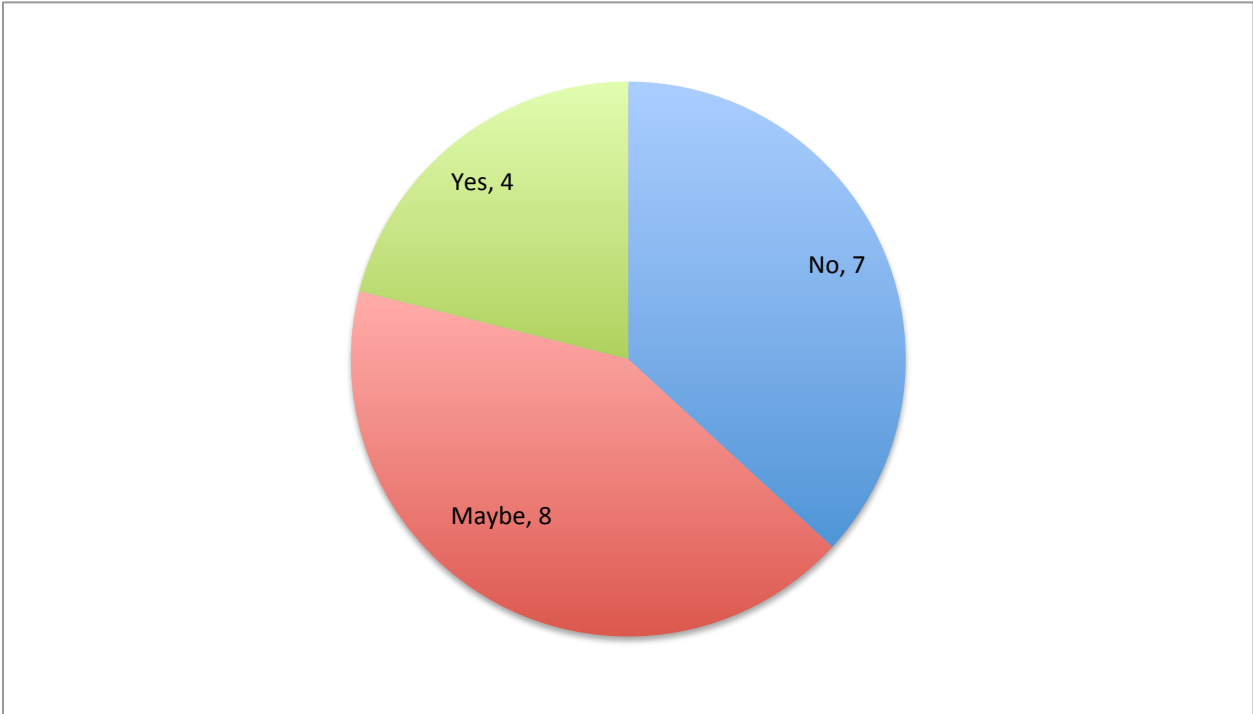

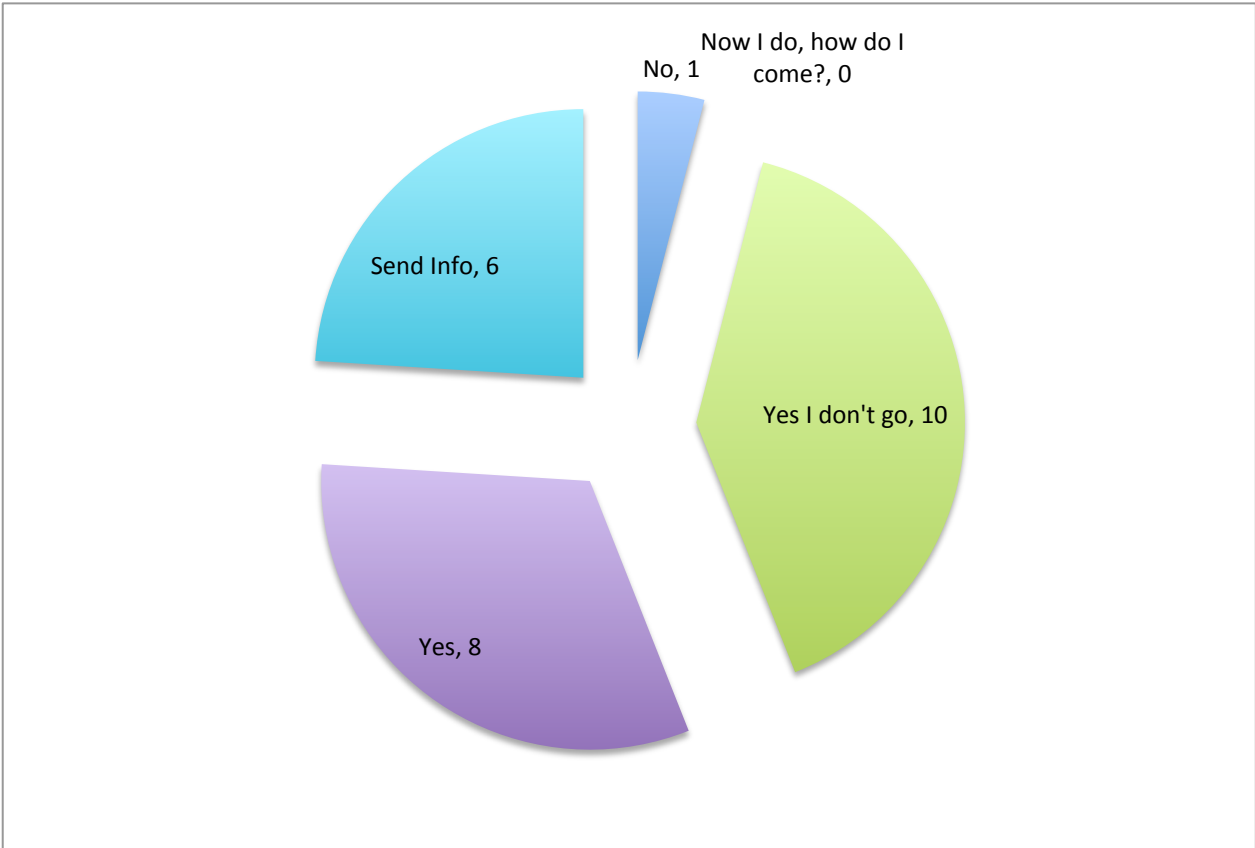

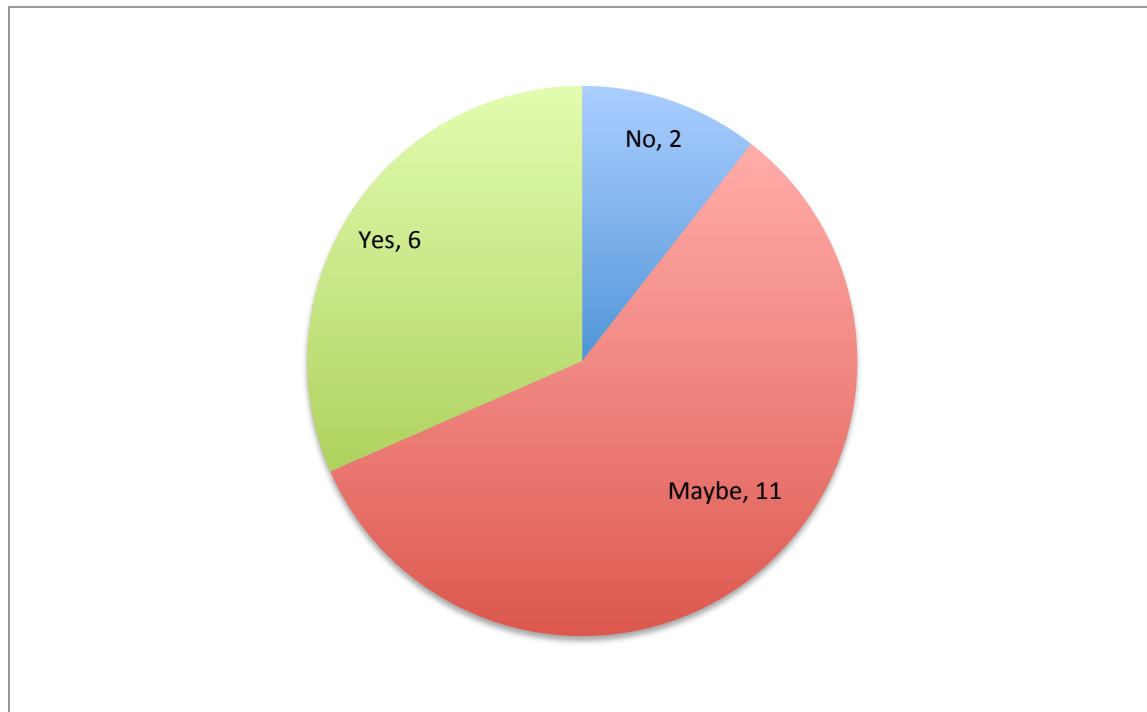

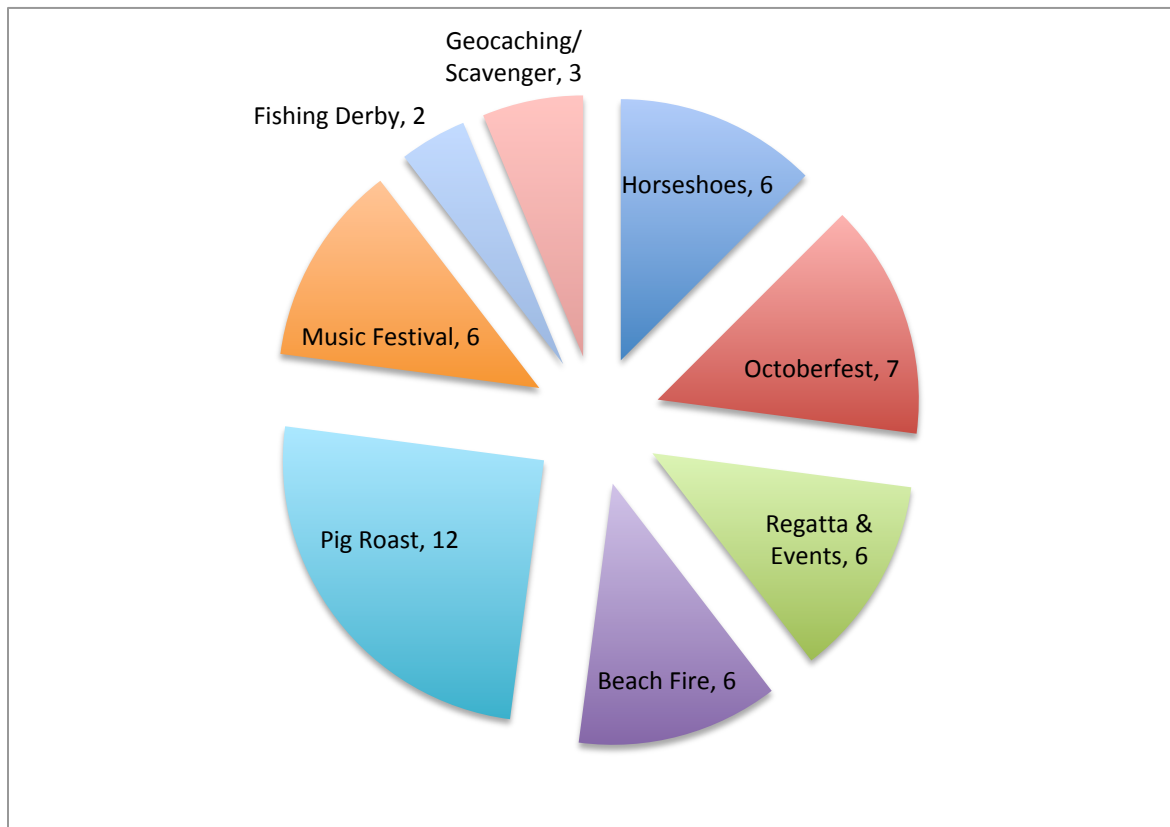
37. Percent of respondents aware of winter fishing derby



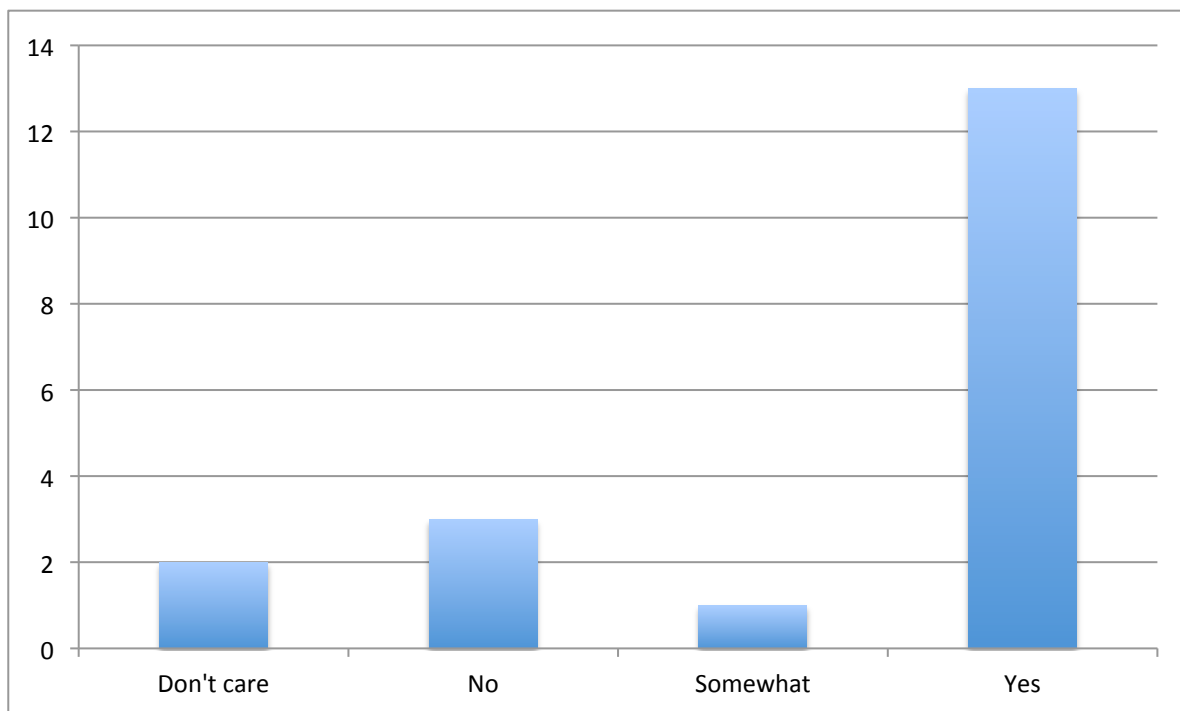

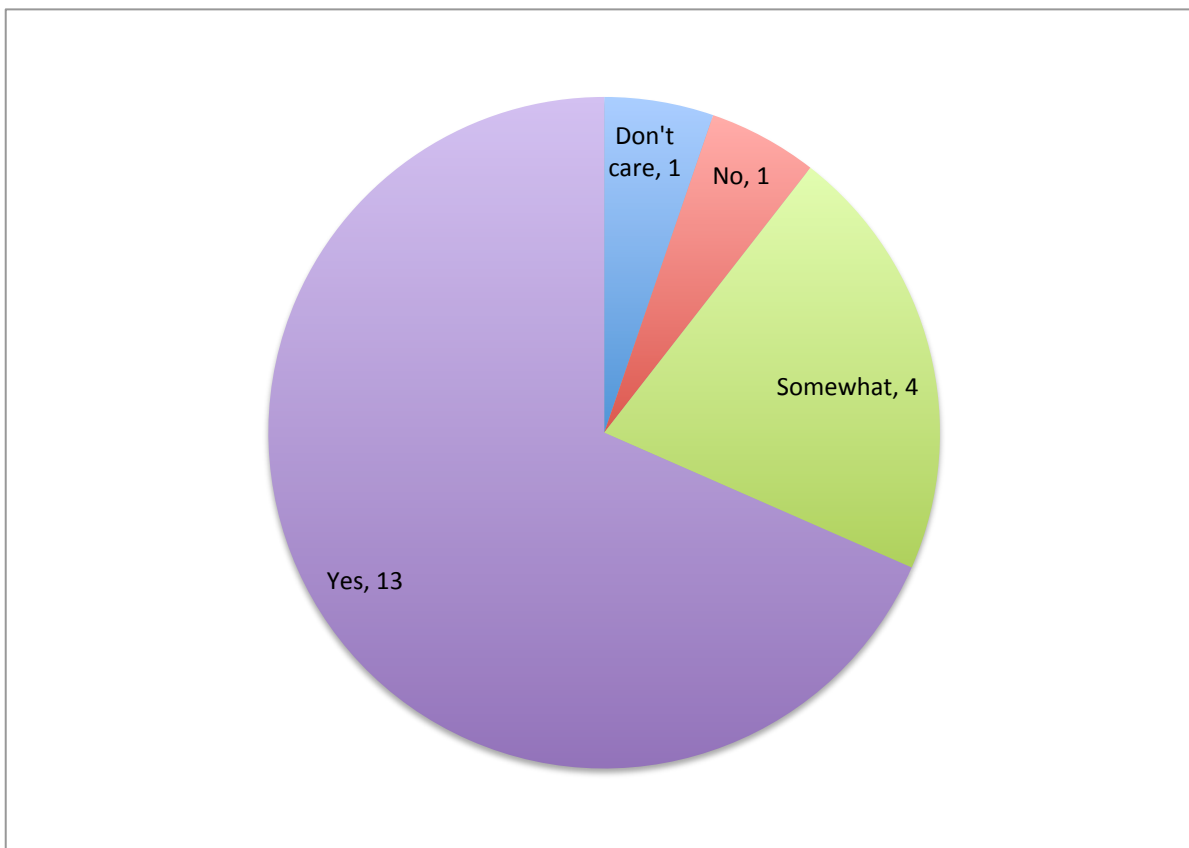

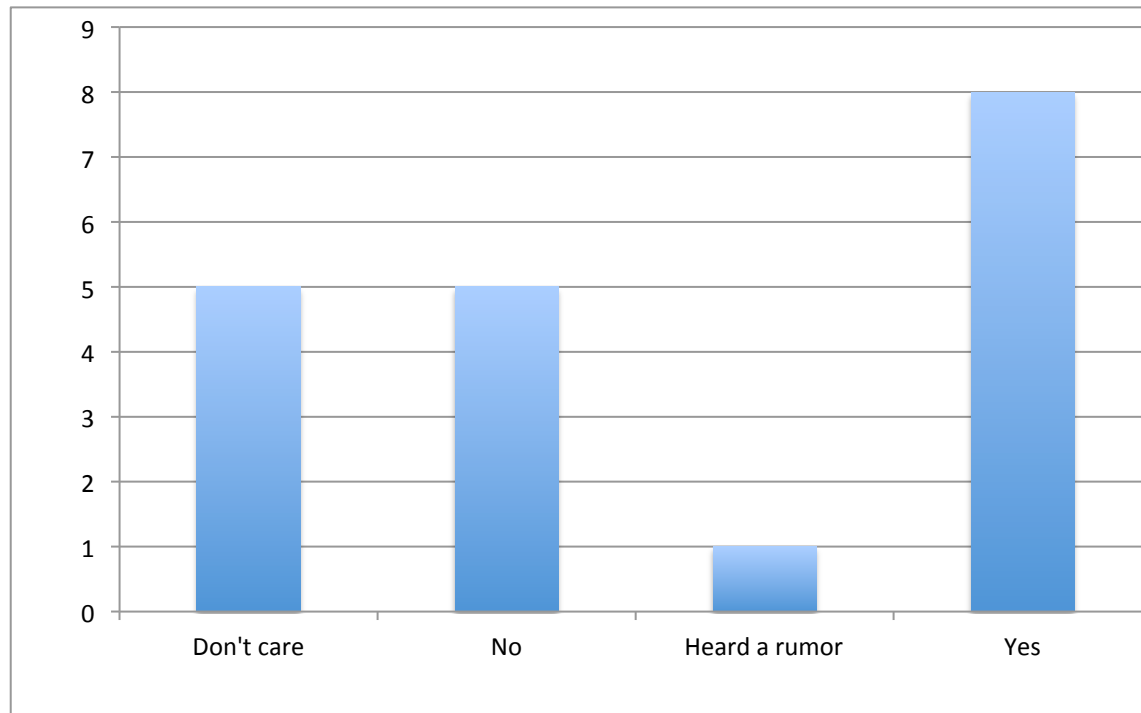

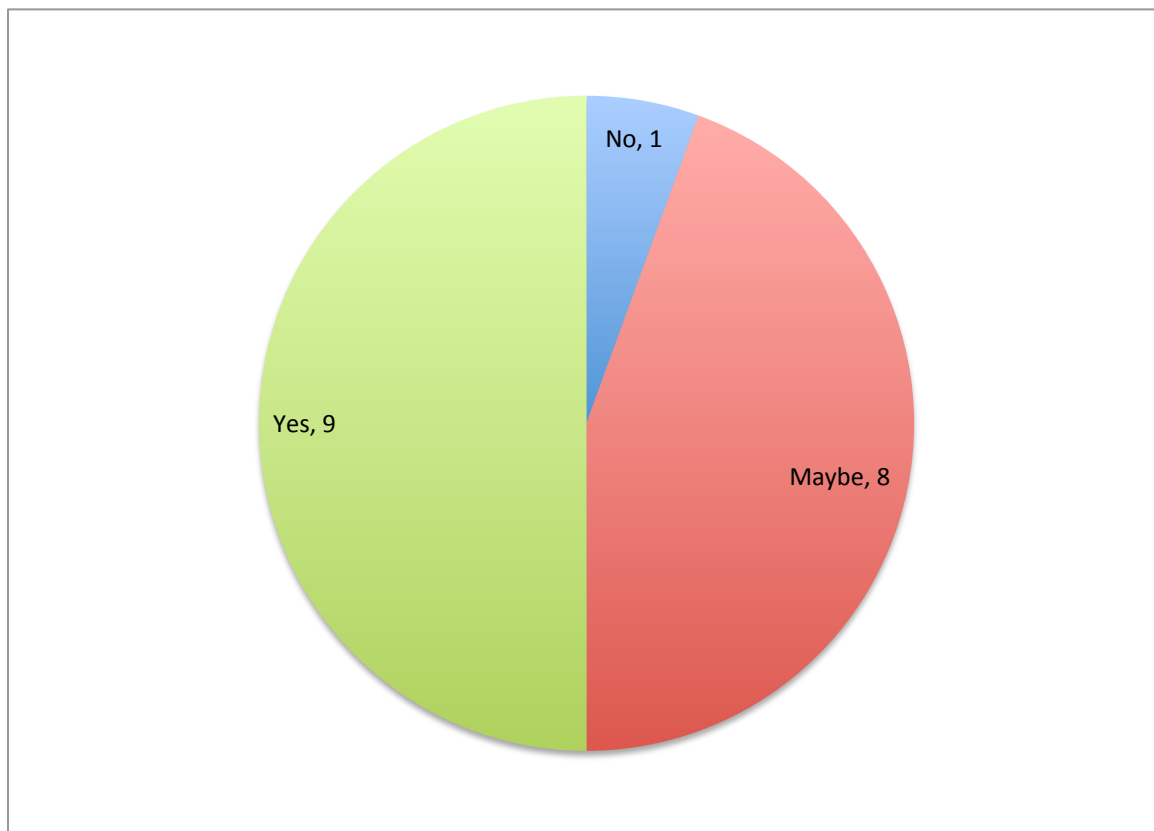
