- 4 Local Citizens' Committee's terms of reference (ToRs) that describe the LCCs' role in the Forest
- 5 Management Planning process. The LCC members provide advice on the development and the
- 6 implementation the Forest Management Plan, participate in public consultation, planning of operations,
- 7 preparation of the Local Citizens' Committee reports and independent forest audits. The LCC members
- 8 represent a wide range of interests.
- 9 LCC members meet regularly with key partners including the Bancroft District MNRF staff, mainly the
- 10 Management Forester, and the Bancroft Minden Forest Company (BMFC) (holder of the Sustainable
- 11 Forest Licence) represented by the General Manager (who is the Forest Management Plan author)

- 20 To date in the FMP process, the LCC has experienced good group mentoring opportunities and an
- 21 ongoing collaborative input process.
- 22 MNRF staff continue to provide support and updates at LCC meetings along with detailed and
- 23 informative presentations provided by the SFL plan author. The committee wishes to express its
- 24 appreciation for the professional effort contributed in keeping them updated and informed on the
- 25 planning process for the Bancroft Minden Forest FMP.

4 ASSESSMENT OF EFFECTIVENESS OF COMMITTEE STRUCTURE AND ANY RECOMMENDATIONS FOR CHANGE;

- 28 Overall, the LCC is pleased with the level of engagement and input we are contributing to the FMP
- 29 process. The PT has always kept the LCC members informed and involved in critical decision points.

- 1 Understanding what input from the LCC is used in the final plan is raised as a concern and will be
- 2 discussed below. The committee is satisfied with the structure of the LCC but acknowledge it is
- 3 sometimes difficult for volunteers to commit the time required to stay informed and provide meaningful
- 4 input. The LCC is pleased with the rigorous member recruitment process that was followed to fill gaps in
- 5 membership and onboard two new members at the start of the planning process.
- 6 In February 2021, LCC members completed a self-evaluation of its effectiveness in plan development as
- 7 part of the CFSA Indicators of Objective Achievement required for the Draft Plan. This mark will be
- 8 reported in FMP-10 under the 'Social and economic harvest levels and community well-being'
- 9 category. The overall mark was 8.0. The headings in the evaluation were: Informed, Involved,
- 10 Influential, Representative, Functioning and Satisfaction. There was also an opportunity to provide
- 11 comments for each category.
- 12 Positive comments included: the group communicates well, good participation from members, feel that
- 13 their stakeholders are being represented through the LCC, Good training opportunities on forest
- management by the plan author, a broad cross section of stakeholders being represented.
- 15 The areas for improvement included: improvements in communicating the expected outcomes for each
- 16 meeting through pre-meeting readings, stakeholder involvement was low due to the presentation of the
- 17 FMP process literature, meetings at times could be monopolized by individual stakeholder interests.
- 18 These comments are noted with some being addressed earlier in this report. The largest area for
- improvement is understanding where the LCC's input influences the final FMP. An attempt at
- addressing this through a 'Formal Feedback Loop' is one suggestion that is being implemented.

21 5 COMMITTEE'S ASSESSMENT OF FMP

The LCC is in full agreement with the 2021-2031 FMP Draft Plan as presented.
